1. Applicant must be above 18 Years of age on the Date of Application.
2. Applicant must be the resident of that respective Panchayat for which he/she wants to apply. Applicant also be the resident of Nabarangpur District.
3. The minimum qualification of the VLE of the CSC is HSC/10<sup>th</sup> pass with basic knowledge of computer and weightage will be given to higher qualified applicant. For selection of VLE under CSC 2.0 Programme preference will be given to the applicant of own Gram Panchayat. In case applicant from respective Gram Panchayats are not available, then applicant of the nearby GP of the same block will be considered. In order to empower the women, preference will be given to women as VLE.
4. Application must be filled up completely in all respects.
5. Applicant is required to affix one recent passport size color photograph on the application form.
6. Self-attested copies of ID Proof (EPIC/Aadhaar Card) and Address Proof is required to be attached along with the application form.
7. Applicants must have to submit Photo of the Location of CSC Center with Proper Latitude and longitude where it is to be function.
8. Self-attested copies of Educational Qualification Certificate, Certificate about Basic Computer Knowledge (Professional Qualification Certificate), Residence Certificate issued from competent authority should have to be furnished by the applicant.
9. The outer envelope is to be superscripted with **“Application for Selection of VLE under CSC 2.0 Project”**.
