**ORDER**

WHEREAS, the Government of Odisha, in exercise of powers conferred u/s 2,3, and 4 of the Epidemic Disease Act, 1897 have enunciated the Odisha COVID-19 Regulation 2020 for prevention and containment of COVID-19.;

AND WHEREAS, the Government in Revenue & Disaster Management (Disaster Management) Department, Odisha vide order No.3856/R&DM(DM) dated 30.06.2020 have issued directions for strict implementation of lockdown as per guidelines to contain the spread of COVID-19;

AND WHEREAS, the Collector & District Magistrate, Nabarangpur has been designated as the Empowered Officer and authorized to enforce and implement various measures for containment of the spread of COVID-19 diseases;

AND WHEREAS, more positive cases of COVID-19 are being detected on every day detected in the following areas of Nabarangpur District, it is felt necessary to impose restrictions on movement of employees of Government and private establishments as well as general public to Hotspot zones/ areas;

NOW THEREFORE, in pursuance of instructions contained at para 10 of order No.3856/R&DM(DM) dated 30.06.2020 of Government in Revenue & Disaster Management Department (Disaster Management), Odisha, Bhubaneswar , I, **Dr. Ajit Kumar Mishra, OAS(SAG), Collector & District Magistrate, Nabarangpur** and the Empowered Officer do hereby direct to implement the following directions:-

1. No government employee as well as Private Establishments working under Nabarangpur District jurisdiction should proceed to any of the hotspot zones of other Districts without prior permission of the District Administration.
2. If any government employee as well as Private Establishments working under Nabarangpur District jurisdiction proceeded to any of the hotspot zones of other Districts with due permission of the District Administration shall have to compulsorily stay in home quarantine for a period of 14 days, observing the guidelines issued by the Health & Family Welfare Department, Odisha.
3. No individual (other than employees of Government and private establishments) in respect of Nabarangpur District jurisdiction should proceed to any of the hotspot zones of other Districts without prior permission of the concerned Sarpanch/BDO/Executive Officer of ULB.
4. If any government employee as well as Private Establishments working under Nabarangpur District jurisdiction proceeded to any of the hotspot zones of other Districts with due permission of the concerned Sarpanch/BDO/Executive Officer of ULB shall have to compulsorily stay in home quarantine for a period of 14 days, observing the guidelines issued by the Health & Family Welfare Department, Odisha.

5. Returnee(s) in rural areas, who are staying under mandatory institutional quarantine for a period of 14 days in different TMCs, whose swab has been collected and sent for swab testing shall not be discharged from the concerned TMC till the result of the Swab test is received.
6. Returnee(s) to the District from other District in respect of both rural and urban areas shall have to compulsorily stay in home quarantine for a period of 14 days, observing the guidelines issued by the Health & Family Welfare Department, Odisha. If the returnee does not have proper quarantine facility at home, he/she shall undergo institutional/paid quarantine for a duration as directed by the local authorities.

Any person found violating the containment measures as stipulated supra will be liable to be prosecuted against as per the provisions of section 51 to 60 of the Disaster Management Act, 2005, and COVID-19 Regulations, 2020, besides, legal action under Sec.188 of the Indian Penal Code and other legal provisions as applicable
