ORDER

WHEREAS, the Government of Odisha, in exercise of powers conferred u/s 2,3, and 4 of the Epidemic Disease Act, 1897 have enunciated the Odisha COVID-19 Regulation 2020 for prevention and containment of COVID-19;

AND WHEREAS, the Government in Revenue & Disaster Management (Disaster Management) Department, Odisha vide order No.3856/R&DM(DM) dated 30.06.2020 have issued directions for strict implementation of lockdown as per guidelines to contain the spread of COVID-19;

AND WHEREAS, the Collector & District Magistrate, Nabarangpur has been designated as the Empowered Officer and authorized to enforce and implement various measures for containment of the spread of COVID-19 diseases;

AND WHEREAS, the detection of positive case of COVID-19 is increasing day by day in Nabarangpur District, it is felt necessary to impose shutdown in the entire District of Nabarangpur.

NOW THEREFORE, in pursuance of instructions contained at para 3 of order No.3856/R&DM(DM) dated 30.06.2020 of Government in Revenue & Disaster Management Department (Disaster Management), Odisha, I, Dr. Ajit Kumar Mishra, OAS(SAG), Collector & District Magistrate, Nabarangpur and the Empowered Officer do hereby direct to implement the following directions:-

1. In the interest of public health and the containment of spread of COVID-19 in the District, shutdown shall be imposed in the entire District of Nabarangpur with effect from 5.00 am of 21.07.2020 till midnight of 22.07.2020 .During this shutdown ,only the following activities shall be allowed.

Government of India establishments:

- i. Defence.
- Central Armed Police Forces. ii.
- Central Government offices on emergency duty. iii.
- iv. Post Offices.
- Telecom services including their maintenance offices and movement of ٧. associated personnel.
- National Informatics Centre vi.
- vii. ATMs.

Government of Odisha establishments:

- viii. State Government officials on emergency duty.
- District Office/ Municipal Administration/ Police/ Fire Services ix.

Utilities and Essential Services:

- All medical establishments including hospitals, clinics, nursing homes, X. including medicine stores. Movement of Ambulance and all medical personnel including Doctors & Paramedics.
- Water supply, Sanitation and sewerage workers. xi.
- Power generation, transmission and distribution. xii.

Transport:

- xiii. Movement of goods and goods carriers, whether loaded or unloaded.
- xiv. Bus Stands and their associated offices, movement of associated personnel and activities.
- xv. Road transport on highways, road movement of transiting vehicles.

Vegetables, Food & Grocery:

- xvi. Shops selling vegetables, grocery and milk between 6 am to 1 pm.
- Home delivery of food, groceries, vegetables, egg, fish, meat and other essential items.

Economic and Other activities:

- xviii. Industrial establishments, factories and construction activities.
- xix. Agriculture, Horticulture, Fisheries, Animal Husbandry, Veterinary Services and allied activities.
- Service Sector industries including IT/ITeS, Hotel & Hospitality units.

 Operation of hotels and hospitality units including their associated offices, movement of staff and associated personnel.
- xxi. Funerals, with permission of District Authority.
- xxii. Patrol Pumps and LPG retail outlets.
- xxiii. Operation of E-commerce establishments such as Flipkart, Amazone etc. including their warehousing and delivery activities.
- xxiv. Print and electronic Media with permission of local authority.
- Dhabas along National and State Highways/Major roads to takeaway
- xxvi. Funerals with permission of local authority.

Any person found violating these measures will be liable to be proceeded against as per the provisions of section 51 to 60 of the Disaster Management Act, 2005, besides, legal action under Sec. 188 of the Indian Penal Code and other legal provisions as applicable.
