ORDER

WHEREAS, the Government of Odisha, in exercise of powers conferred u/s 2,3, and 4 of the Epidemic Disease Act,1897 have enunciated the Odisha COVID-19 Regulation 2020 for prevention and containment of COVID-19.;

AND WHEREAS, the Government in Revenue & Disaster Management (Disaster Management) Department, Odisha vide order No.3856/R&DM(DM) dated 30.06.2020 have issued directions for strict implementation of lockdown as per guidelines to contain the spread of COVID-19;

AND WHEREAS, the Collector & District Magistrate, Nabarangpur has been designated as the Empowered Officer and authorized to enforce and implement various measures for containment of the spread of COVID-19 diseases;

AND WHEREAS, **21(TWENTY-ONE)** more positive cases of COVID-19 have been detected in the following areas of Nabarangpur District, it is felt necessary to make the affected area as containment zone and to restrict the public for entering into and going out from the containment zone;

NOW THEREFORE, in pursuance of instructions contained at para 3 of order No.3856/R&DM(DM) dated 30.06.2020 of Government in Revenue & Disaster Management Department (Disaster Management), Odisha, Bhubaneswar , I, **Dr. Ajit Kumar Mishra, OAS(SAG), Collector & District Magistrate, Nabarangpur** and the Empowered Officer do hereby direct to implement the following directions:-

A. CONTAINMENT ZONE & BUFFER ZONE:

I) The period of **CONTAINMENT ZONE and BUFFER ZONE** in respect of the following areas of Nabarangpur District declared vide District Office Order No.2486 dated 18.07.2020 till midnight of 28.07.2020 and District Office Order No.2520 dated 22.07.2020 is hereby extended **till the midnight of 05.08.2020**.
