## ORDER

WHEREAS, the Government of Odisha, in exercise of powers conferred u/s 2.3. and 4 of the Epidemic Disease Act, 1897 have enunciated the Odisha COVID-19 Regulation 2020 for prevention and containment of COVID-19.:

AND WHEREAS, the Collector & District Magistrate, Nabarangpur has been designated as the Empowered Officer and authorized to enforce and implement various measures for containment of the spread of COVID-19 diseases under Regulation 2 of the Odisha Covid-19 Regulations, 2020;

AND WHEREAS, in view of the COVID-19 pandemic in the State, Government of Odisha has discouraged large gatherings along with other preventive measures to contain the spread of the decease communicated vide letter No. 26527/SAPW dated 10.08.2020 of Government in Home Department, Odisha, Bhubaneswar and issued the following godliness/ stipulations for strict adherence in connection with celebration of Independence Day, 2020.

NOW THEREFORE, in exercise of powers conferred under Regulation 8 the Odisha Covid-19 Regulations, 2020 read with instructions contained in Para No.3 of Order No.4582/R&DM(DM) dated 31.07.2020 of Chief Secretary, Odisha, I, Dr. Aiit Kumar Mishra. OAS(SAG), Collector & District Magistrate, Nabarangpur and the Empowered Officer do hereby direct to implement the following guidelines/ procedure issued by the State Government of Odisha.-

- 1. There will be no parade / marchpast.
- 2. There will be no participation by the general public in the District level Independence Day Celebrations.
- 3. No Student will be asked to attend school to participate in Independence Day celebration.
- 4. The Head Master/teacher will attend flag hoisting ceremony following COVID guidelines/ safety protocol i.e. wearing of mast, social distancing, etc.
- 5. Congregation during flag hoisting ceremony in all Govt., Private, aided Schools, Colleges and all other Private Institutions etc. should not exceed 10 persons.
- 6. No eatable will be distributed in the flag hoisting ceremony in Schools/ Colleges / Government / Private Institutions etc.
- 7 The process of observation of Independence Day in Schools/ Colleges celebrations should be completed within 9.00 AM to 11.00 AM
- The process of observation of Independence Day in Government / Private Institutions. celebrations should be completed within 7.30 AM to 9.00 AM
  - All the guidelines issued by the Health & Family Welfare Department/ SRC, Odisha will be followed 0/2020
