<u>ORDER</u>

WHEREAS, the Government of Odisha, in exercise of powers conferred u/s 2,3, and 4 of the Epidemic Disease Act,1897 have enunciated the Odisha COVID-19 Regulation 2020 for prevention and containment of COVID-19.;

AND WHEREAS, the Collector & District Magistrate, Nabarangpur has been designated as the Empowered Officer and authorized to enforce and implement various measures for containment of the spread of COVID-19 diseases under Regulation 2 of the Odisha Covid-19 Regulations,2020;

AND WHEREAS, the Collector & District Magistrate, Nabarangpur has been designated as the Empowered Officer and authorized to enforce and implement various measures for containment of the spread of COVID-19 diseases;

AND WHEREAS, **28(TWENTY-EIGHT)** more positive cases of COVID-19 have been detected in the following areas of Nabarangpur District, it is felt necessary to make the affected area as containment zone and to restrict the public for entering into and going out from the containment zone;

NOW THEREFORE, in exercise of powers conferred under Regulation 8 the Odisha Covid-19 Regulations, 2020 read with instructions contained in Para No.1 of Order No.5627/R&DM (DM) dated 01.10.2020 of Special Relief Commissioner & Additional Chief Secretary, Odisha, I, Sri Ramakanta Nayak, OAS (S), Project Director, DRDA, Nabarangpur & in Charge of Collector, Nabarangpur and the Empowered Officer do hereby direct to implement the following directions:-

A. <u>CONTAINMENT ZONE & BUFFER ZONE:</u>

I) The period of **CONTAINMENT ZONE and BUFFER ZONE** in respect of the following areas of Nabarangpur District, declared vide District Office Order No.3123 dated 08.10.2020, Order No.3146 dated 11.10.2020, is hereby extended till the **midnight of 22.10.2020**.

3. The Officials in respect of essential services/ officials engaged in COVID-19 related duty shall show the ID cards, if demanded by the Police Authorities on duty.
