**ORDER**

Whereas, the Government of Odisha have declared the **COVID-19** as a "**Disaster**" for the state of Odisha vide Notification No.1706 dated 13.03.2020 of Revenue & Disaster Management Department, Odisha, Bhubaneswar.

Whereas, the Government of Odisha communicated vide Order No.7384/R&DM (DM) dated 30.12.2021 of Chief Secretary, Odisha have promulgated the guidelines in the State of Odisha from 01.01.2021 to 31.01.2021.

Whereas, in pursuance of standard instructions / advisory issued by the Government in Health & Family Welfare Department, Odisha for prevention and control of Corona Virus Disease (Covid-19) and for strict implementation of the Odisha COVID-19 Regulations, 2020, I Dr. Ajit Kumar Mishra, O.A.S.,(SAG), District Magistrate & Collector, Nabarangpur, do hereby pass the following orders under section 144(1) of Cr.P.C read with section 144(2) of Cr.P.C. for the period **between 10.00 pm of 31.12.2020 to 5.00 am of 01.01.2021**, except for essential activities.

1. **The movement of individuals shall remain strictly prohibited**
2. No gathering of more than 05(five) persons will be allowed in Nabarangpur district jurisdiction in any public or private places except gathering inside house or house premises
3. Non-essential gatherings and assemblies such as seminars, workshops, and conferences are to be cancelled.
4. Social gatherings and assemblies like religious functions, marriage receptions, parties etc. shall not be conducted.
5. No Marriage Barat/ Opera shows / and other functions shall be organized.
6. No Political rally / gathering for agitation should be conducted.
7. Any type of Kalyan Mandap shall not be permitted to any functions where public gathering possibilities.
8. The Sub Divisional Magistrate, Nabarangpur/ all the Executive Magistrates, IICs of Police Stations of this district are hereby directed to keep a close watch on gathering of individuals in their respective areas.
9. Any person disobeying the above orders made under section 144 Cr.P. will be liable to be prosecuted against as per the provisions of section 51 to 60 of the Disaster Management Act, 2005, and COVID-19 Regulations, 2020, besides, legal action under Sec.188 of the Indian Penal Code and other legal provisions as applicable.



Further, during the night curfew on 31.12.2020 from 10.00 pm to 5.00 am of 01.01.2021 only the following activities shall be allowed:


1. All medical establishments including hospitals, clinics, nursing homes, including medicine stores. Movement of Ambulance and all medical personnel.
2. Block and Municipal Administration/ Police/ Fire Services.
3. Central & State Government officials on emergency duty.
4. Telecom services/ Petrol pumps.
5. Electronic Media identified by District Police.
6. Water supply, sanitation and sewerage workers.
7. Electricity supply and distribution.
8. Movement of goods and good carriers, whether loaded or unloaded
9. Hotel & Hospitality units.
