ORDER

WHEREAS, the Government of Odisha, in exercise of powers conferred u/s 2,3, and 4 of the Epidemic Disease Act,1897 have enunciated the Odisha COVID-19 Regulation 2020 for prevention and containment of COVID-19.;

AND WHEREAS, the Collector & District Magistrate, Nabarangpur has been designated as the Empowered Officer and authorized to enforce and implement various measures for containment of the spread of COVID-19 diseases under Regulation 2 of the Odisha Covid-19 Regulations,2020;

Whereas, in pursuance of the instructions contained in letter No.923/R&DM(DM) dated 21.02.2021 of Special Relief Commissioner & Additional Chief Secretary to Government(Disaster Management), Odisha I, **Dr. Ajit Kumar Mishra, O.A.S., (SAG), District Magistrate & Collector, Nabarangpur**, do hereby promulgate the following immediate measures for strict enforcement and implementation of Covid-19 Guidelines/ safety protocol provisions and to prevent spike in number of new covid-19 positive cases in the district-

- 1) All the Tahasildars/ Block Development Officers / I.I.Cs / O.I.Cs / Executive Officers , Municipality, Nabarangpur and Umerkote shall check and ensure strict observance of COVID-19 safety protocols such as mandatory wearing of mask, maintaining physical distancing in all public places including work places and educational institutions.
- 2) Public awareness through loudspeaker announcements is to be made frequently in all market places, haat , religious institutions and other crowd places.
- 3) Concerned authorities of Government and private offices / institutions including educational institutions shall be responsible for due compliance of the COVID-19 safety protocols in their respective establishments. Staff attending offices/ commercial establishments must wear face mask, ensure hand sanitization in the entrance of the offices, and maintain social distance among the staffs and public visiting offices / commercial establishments.
- 4) Large congregations must be avoided and wherever permission has been granted for marriages, other social / religious functions, sports, entertainment/ academic/ cultural/ any other gathering/ congregations, compliance of the COVID-19 safety protocols and crowd size in such gatherings shall be strictly monitored by the enforcement authorities i.e. Tahasildars/ Block Development Officers / I.I.Cs / O.I.Cs / Executive Officers , Municipality, Nabarangpur and Umerkote . Under no circumstances, persons more than the number permitted shall be entertained in all such gatherings.

- 5) Adequate and strict sanitation measures are to be maintained in schools, colleges and other educational institutions and Anganwadi Centres. The teachers and concerned authorities shall ensure observance of COVID-19 protocols such as mandatory wearing of mask, maintaining physical distancing and provisions of thermal scanning & hand wash or use of sanitizer by the students, teachers, staff and others.
- 6) Any person found with COVID-19 symptoms must be immediately reported to the nearest health institution and necessary further action be taken as per advice of the health authorities.
- 7) Nothing other than the curricular activities shall be allowed in educational institutions.
- 8) Hotels, restaurants, dhabas and other places of public eating must be closely monitored by the concerned I.I.Cs/ O.I.Cs of Police Stations so as to ensure strict compliance of physical distancing norms and other safety protocols.
- 9) Senior Officers, District Level Nodal Officers shall visit different places/ institutions during their field visits to ascertain and ensure Covid-19 safety protocol compliance. Persons violating the COVID-19 Guidelines/ Protocols may be penalised under the relevant provisions of law.
- 10) The C.D.M & P.H.O, Nabarangpur should ensure adequate testing levels as per guidelines.
- 11) Active contact tracing and travel history of all COVID positive cases to be ensured by the Block Dev. Officers and Medical Officers of concerned CHCs
- 12) ASHA, Anganwadi Workers and ANMs are instructed for early identification and referral for testing of suspected cases.
- 13) Strict adherence of COVID-19 Guidelines/ Protocols in Public & Private Transport Services shall be maintained. All the Staff as well as the passengers must wear mask and unnecessary over crowded in Public/ Private transport services shall not be allowed.
- 14) Salons, Spas, Beauty Parlors and Barber shops shall ensure all safety precautions, disinfections and sanitization before and after service of each customer. The onus of compliance to the guideline lies with the owner, who shall be liable for any violation which may lead to penal action including closure/sealing of the premises.
- 15) As per Rule 2(ii) of Odisha COVID-19 Regulation, 2020, the Additional District Magistrate, Nabarangpur/ CDM&PHO, Nabarangpur/ Sub Collector, Nabarangpur/ all Tahasildar /all Block Dev. Officers / Executive Officer, Municipality, Nabarangpur & Umerkote are empowered to act to take all necessary actions for enforcement and implementation of aforesaid guidelines. Local police shall render necessary assistance as and when requisitions by the aforesaid officers.
- 16) Strong penal action shall be taken against the persons violating the COVID-19 Guidelines/ safety protocols. Shops and other commercial establishments found violating such norms may be sealed and action as per law be taken against such violators.
- 17) Any person found violating these measures will be liable to be proceeded against as per the provisions of section 51 to 60 of the Disaster Management Act, 2005, the Epidemic Diseases Act, 1897 and Regulations issued thereunder besides, legal action under Sec.188 of the Indian Penal Code and other legal provisions as applicable.


