

**Proceeding of the Selection Committee meeting for selection and engagement of
Gram Rozgar Sevak (GRS) held on dated. 18.02.2021 at 5.00 P.M in the
Ashok Meheta Conference Hall, Nabarangpur**

A meeting of the Selection Committee was held under the Chairmanship of Collector, Nabarangpur on dated. 18.02.2021 at 5.00 P.M. The members present in the meeting is enclosed as **Annexure-A**.

The following discussions were made in the meeting:-

At the outset, the Project Director, DRDA, Nabarangpur apprised the committee afresh that, in response to publication of 165 provisionally eligible & 1722 provisionally ineligible list after disposal of objections, the screening committee revised the list of 165 provisionally eligible and 1728 provisionally ineligible, Rejected 988 and Disqualified 97 with 1 double. So the figure comes to 2978 nos. The Project Director, DRDA, Nabarangpur apprised these list have not been published but as per the discussion in the Selection committee meeting dated. 04.11.2020, the core committee examined the computer proficiency certificates of 165 provisionally selected candidates list as per Govt. Letter No. 13284 dated. 24.08.2020 and observed that 48 candidates out of 165 provisionally eligible list having valid Govt. recognised computer certificates, 117 candidates were dropped from the provisionally eligible list as they don't have valid Govt. recognized Computer certificate. As per the guideline issued by PR & DW Deptt. Vide No. 6681 dated. 06.04.2018, a panel of successful candidates shall be prepared in the ratio of 1:3 based on merit as per the vacancy. Accordingly a panel of 99 successful candidates is required to be published before the final selection and engagement of vacant post of GRS i.e. 33. In order to prepare a panel of 99 candidates, 51 candidates having valid Govt. recognised computer certificate out of provisionally ineligible 1728 (below cut off mark) were taken to the zone of consideration. The above 51 candidates taken out of provisionally ineligible 1728 below (cut off mark) have been taken out of 303 candidates as per merit. The rest 252 candidates were kept in the rejected list for not having the Govt. recognised computer certificate.

For better transparency, it was discussed & decided in the Selection Committee that all the eligible and rejected candidates i.e. 48+51 and 117+252 be published in the website inviting objection to which the committee unanimously agreed. The list is listed below.

The Project Director, DRDA, Nabarangpur apprised the committee that, 04 PwD candidates were initially in the 165 provisionally eligible list. After verification by the core committee it was found that all the 04 PwD candidates have not submitted Govt. recognized computer certificate for which they were dropped from the 165 provisionally eligible list and enlisted in the rejected list. The committee after through verification of the 1728 list observed that none of PwD candidates posses valid computer certificate and found to be not eligible. The committee observed that 1 out of 33 advertised posts may lie vacant for want of eligible PwD candidate.

The Collector-cum-Chairman of Selection Committee directed that, after webhost of the list inviting objections giving 15 days time all the objections shall be heard by the selection committee headed by Collector/ADM for disposal of the objections and finalization of merit list of 99 nos. of candidates.

The meeting ended with votes of thanks to the chair and members present.
