In continuation to this office Notice No. 475 dated. 26.05.2020 relating to recruitment of candidates for the post GRS, it is hereby notified that after disposal of their objections and as per revised instruction vide letter no. 13284 dated. 24.08.2020 of Additional Secretary to Govt. PR &DW Department on requisite qualification in computer proficiency the list of candidates was verified with respect to computer proficiency and it is observed that 48 candidates out 165 provisionally eligible list and 51 candidates out of provisionally ineligible list of 1728 up to Sl no. 303 on merit posses valid computer certificates for which the list of 48 eligible & 117 not eligible of 165 list and 51 eligible and 252 not eligible for the list up to 303 out of 1728 list are hereby published in the website inviting objections if any with the following terms and conditions: -

04. The last date and time of sending objection by online / Registered Post / Speed Post is 5.30 P.M of the 15th day. Any objection beyond the stipulated day and time will not be entertained.
05. The objection must be in the prescribed format notified herewith. Objection in any other format / manner will not be accepted for consideration by the selection committee.
06. As per the decision of the selection committee meeting dated. 18.02.2021, the said objections will be heard by the selection committee headed by the Collector/ADM for disposal of the objections and for finalisation of the merit list of 99 nos. of candidates including waiting list in the ratio of 1:3.
