ORDER

WHEREAS, the Government of Odisha, in exercise of powers conferred u/s 2,3, and 4 of the Epidemic Disease Act,1897, have enunciated the Odisha COVID-19 Regulation 2020 for prevention and containment of COVID-19.;

AND WHEREAS, the Collector & District Magistrate, Nabarangpur has been designated as the Empowered Officer and authorized to enforce and implement various measures for containment of the spread of COVID-19 diseases under Regulation 2 of the Odisha Covid-19 Regulations,2020;

AND WHEREAS, the Government of Odisha vide Order No.1020/R&DM (DM) dated 27.02.2021 have specifically directed that large gatherings shall continue to be prohibited. Social ,political, sports, entertainment, academic, cultural and religious functions and other gatherings shall be allowed with a ceiling of 500 persons subject to strict adherence of the COVID-19 safety protocols.

AND WHEREAS, resurgence of SARS-Cov-2(Covid-19) have been noticed in many parts of the world and in many parts of India such as Maharastra, Punjab, Karnataka, Gujarat, Madhya Pradesh and Kerala etc;


NOW THEREFORE, in order to prevent the outbreak of Corona Virus Disease (Covid-19) or the spread thereof in respect of Nabarangpur district jurisdiction, I, **Dr. Ajit Kumar Mishra, O.A.S., (SAG), District Magistrate & Collector, Nabarangpur**, do hereby pass the following orders under section 144(1) of Cr.P.C read with section 144(2) of Cr.P.C. that the **movement of individuals shall remain strictly prohibited during night curfew between 8.00 pm to 6.00 am except for essential activities with effect from 25th March, 2021.**

1. No gathering of more than 05(five) persons will be allowed in Nabarangpur district jurisdiction in any public or private places except gathering inside house or house premises.
2. Non-essential gatherings and assemblies such as seminars, workshops, and conferences are to be cancelled.
3. Social gatherings and assemblies like religious functions, marriage receptions, parties etc. shall not be conducted.
4. No Marriage Barat/ Opera shows / and other functions shall be organized.
5. No Political rally / gathering for agitation should be conducted.
6. Any type of Kalyan Mandap shall not be permitted to any functions where public gathering possibilities.
7. All the Hotels where people stay on regular basis coming from outside should keep all precautionary measures of COVID-19 like sanitizer and isolation room during the period.
8. Anybody with signs and symptoms like cough, fever or difficulty in breathing should call the district helpline No.06858-222459, Mobile No.9439988787, 9439988468/ District COVID Control Room No.06858-222434.

9. The Sub Divisional Magistrate, Nabarangpur/ all the Executive Magistrates, IICs of Police Stations of this district are hereby directed to keep a close watch on gathering of individuals in their respective areas.
10. Any person disobeying the above orders made under section 144 Cr.P.C and shall be deemed to have committed an offence punishable under section section 51 to 60 of the Disaster Management Act, 2005 ,and COVID-19 Regulations, 2020, besides, legal action under Sec.188 of the Indian Penal Code and other legal provisions as applicable
11. Rumor mongering, mis-information in social media will be dealt with very sternly.
12. This order shall remain in force till it is revoked or rescinded.

Further, the above restrictions shall not apply to Medical Stores/ Pathological Labs and Clinics/ Veterinary Hospitals / Patrol Pumps / LPG, Petroleum and Gas Retail and Storage out lets / Lodgings etc.
