ORDER

WHEREAS, the Government of Odisha, in exercise of powers conferred u/s 2,3, and 4 of the Epidemic Disease Act,1897, have enunciated the Odisha COVID-19 Regulation 2020 for prevention and containment of COVID-19.;

AND WHEREAS, the Collector & District Magistrate, Nabarangpur has been designated as the Empowered Officer and authorized to enforce and implement various measures for containment of the spread of COVID-19 diseases under Regulation 2 of the Odisha Covid-19 Regulations, 2020;

AND WHEREAS, the Government of Odisha vide Order No.1714/R&DM (DM) dated 03.04.2021 have directed that Night Curfew in the district of Nabarangpur shall be in formce from 05.04.2021 till further orders.

NOW THEREFORE, in pursuance of Order No.1714/R&DM (DM) dated 03.04.2021 of Chief Secretary, Odisha and to prevent transmission of infection, I, Dr. Ajit Kumar Mishra, O.A.S., (SAG), District Magistrate & Collector, Nabarangpur, do hereby pass the following orders under section 144(1) of Cr.P.C read with section 144(2) of Cr.P.C. that the all shops, commercial establishments, offices, institutions and movement of individuals shall remain closed/ prohibited during night curfew between 10.00 pm to 5.00 am from 05.04.2021 till further orders with following guidelines;

- 1. All shops, commercial establishments, offices, institutions and movement of individuals shall remain closed.
- 2. Movement of individuals shall remain prohibited.
- Non-essential gatherings and assemblies such as seminars, workshops, and conferences are to be cancelled.
- 4. Social gatherings and assemblies like religious functions, marriage receptions, parties etc. shall not be conducted.
- 5. No Marriage Barat/ Opera shows / and other functions shall be organized.
- 6. No Political rally / gathering for agitation should be conducted.
- Any type of Kalyan Mandap shall not be permitted to any functions where public gathering possibilities.
- All the Hotels where people stay on regular basis coming from outside should keep all
 precautionary measures of COVID-19 like sanitizer and isolation room during the period.
- Anybody with signs and symptoms like cough, fever or difficulty in breathing should call the district helpline No.06858-222459, Mobile No.9439988787, 9439988468/ District COVID Control Room No.06858-222434/7077450077
- 10. The Sub Divisional Magistrate, Nabarangpur/ all the Executive Magistrates, IICs of Police Stations of this district are hereby directed to keep a close watch on gathering of individuals in their respective areas.
- 11. Rumor mongering, mis-information in social media will be dealt with very sternly.
- 12. This order shall remain in force till it is revoked or rescinded.

The above restrictions shall not apply to-

- a) District and Municipal Administration/Police/ Government Officials on duty.
- b) Doctors, medical / Paramedical staff (Govt. & Private), ambulances and emergency health staff.
- c) Emergency workers of utilities such as Electricity, Fire Services, Telecom, Water Supply, Transport services.
- d) Staff of IT & ITeS Companies on production of their ID cards.
- e) Any person, in case of medical or other emergency.
- f) Owner/Staff of Chemist Shops.
- g) All industrial activities.
- h) All construction activities.
- i) Movement of Public Transport, private vehicles and taxis(including cabs by aggregators like Ola, Uber etc.) to and from airports, railway station and bus terminals /stands/ stops, for facilitating movement of passengers by air, rail and road.
- Operation of hotels and hospitality units, including their associated offices, movement of staff and associated personnel.
- k) Dhabas along National and State Highways/ Major roads for takeaway only.
- Petrol pumps.
- m) Print and Electronic Media identified by District Police (with identity cards of respective media houses).
- n) LPG distribution, home delivery of cooking gas and associated facilities, personnel and vehicular movement.
- Home Delivery of food, groceries, vegetables, egg, fish, meat and other essential items by restaurants and aggregators.
- p) No pass would be required for movement of above category of persons. Valid Travel documents/ authorizations such as airline/railway/ bus tickets/ boarding passes, with any identity proof shall be adequate for the purpose.
- q) Identity cards issued by appropriate authorities of the establishments shall serve as pass for effecting movement of employees of establishments under permitted activities.
- r) Patients and their attendants / persons requiring emergency need for movement shall be allowed to move with minimal proof of their emergencies.
- s) Officers/ Staff on duty shall be sensitized to appreciate the situation of persons on the road and take suitable action to facilitate movement on emergency needs.

Any person disobeying the above orders made under section 144 Cr.P.C and shall be deemed to have committed an offence punishable under section section 51 to 60 of the Disaster Management Act, 2005 ,and COVID-19 Regulations, 2020, besides, legal action under Sec.188 of the Indian Penal Code and other legal provisions as applicable
