**ORDER**

WHEREAS, the Government of Odisha, in exercise of powers conferred u/s 2,3, and 4 of the Epidemic Disease Act,1897 have enunciated the Odisha COVID-19 Regulation 2020 for prevention and containment of COVID-19.;

AND WHEREAS, the Collector & District Magistrate, Nabarangpur has been designated as the Empowered Officer and authorized to enforce and implement various measures for containment of the spread of COVID-19 diseases under Regulation 2 of the Odisha Covid-19 Regulations,2020;

AND WHEREAS, 207(TWO HUNDRED AND SEVEN) more positive cases of COVID-19 have been detected in the following areas of Nabarangpur District, it is felt necessary to make the affected area as containment zone and to restrict the public for entering into and going out from the containment zone;

NOW THEREFORE, in exercise of powers conferred under Regulation 8 the Odisha Covid-19 Regulations, 2020 read with instructions contained in Para No.1 of Order No.1663/R&DM (DM) dated 31.03.2021 of Chief Secretary, Odisha, I, **Dr.Ajit Kumar Mishra, OAS(SS), District Magistrate & Collector, Nabarangpur** and the Empowered Officer do hereby direct to implement the following directions:-

**CONTAINMENT ZONE:**

1) The period of **CONTAINMENT ZONE** in respect of the following areas of Nabarangpur District, declared vide Office Order No.4150 dated 11.04.2021, Order No.4266 dated 12.04.2021, Order No.4485 dated 16.04.2021, Order No.4541 dated 19.04.2021, Order No.4581 dated 20.04.2021, Order No.4588 dated 21.04.2021 is hereby extended till the **midnight of 02.05.2021**.

- During the aforesaid period, no public shall be allowed to move into or go out of containment zone. All the inhabitants in the containment zone shall strictly remain inside.
- All Shops/ establishments/ markets and whatsoever nature within the containment zone shall be remain closed except supply of essential and medical requirements through various teams authorized by the District Administration.
- The Officials in respect of essential services/ officials engaged in COVID-19 related duty shall show the ID cards, if demanded by the Police Authorities on duty.
- During the period **till midnight of 02.05.2021**, there shall be intensive contact tracing, house-to house surveillance and other clinical interventions.
- The Medical Officer-in-Charge, ANM, Asha Workers of the concerned and Authorities shall launch a massive operation and enlist all such persons who may have come in contact with the COVID-19 positive patient, assist the District Administration in intensive contact tracing and render all assistance to the District Administration as required.
- The following officers are hereby declared as Nodal Officer to ensure smooth supply of essential/ facilities in respect of Containment zone under the close supervision of **Sri Bhaskar Roita, O.A.S. (SB), Sub Collector, Nabarangpur (Mobile No.9439613560)**.
