

**Proceeding of the Selection Committee meeting for selection and engagement of Gram Rozgar Sevak (GRS) held on 16.06.2021 at 11.30 A.M through Virtual Mode**

A meeting of the Selection Committee was held under the Chairmanship of Collector, Nabarangpur on dated. 16.06.2021 at 11.30 A.M. The members present in the meeting through virtual mode is enclosed as **Annexure-A**.

The following discussions were made in the meeting:-

At the outset, the Project Director, DRDA, Nabarangpur apprised the committee that, in response to the publication made vide Notice No- 178 dated. 20.02.2021 of Collector-cum-Chairman, Selection Committee of the list inviting objection for 15 days i.e.

It is seen that, 57 objections have been filed by the applicants in due time i.e. from 22.02.2021 to 08.03.2021. Out of these 02 nos. of applications are not related to GRS Post and 14 nos. of duplicate objections received. The rest 41 objections have been duly heard by the Additional District Magistrate, Nabarangpur and out of which 39 objections are being rejected. Besides 3 nos. of writ petitions i.e. WP(c) No- 8624/21 (Sri Asim Panigarhi-vrs- State and Others), WP(C) No- 8627/21 (Sri Ganeswar Bissoi-vrs- State and Others) and WP(C) No- 8630/21 (Sri Tunesh Kumar Sahu-vrs-State and Others) have been considered as per the direction of the Hon'ble High Court by the Project Director, DRDA, Nabarangpur-cum-O.P No-04 and disposed off with rejection being devoid of merit. The rest two nos. of objections filed before Additional District Magistrate, Nabarangpur relating to Miss Basanti Dongri and Sri Narahari Muduli related to reservation category and marks obtain in +2 / diploma respectively placed before the selection committee for disposal. Accordingly after discussion the selection committee directed to change the category of Miss Basanti Dongri to UR Category and for Sri Narahari Muduli to accept 74.54% as his 10+2 mark basing on his diploma mark sheet instead of 64.50% marks secured in +2 examination and decided to prepare the merit list as per the advertisement made for 33 nos. of vacancies keeping 1:3 ratio for selection and waiting.

The Committee after due deliberation resolved that as there is reservation of 4% for PwD candidates out of 33 vacancies which comes to 1 post but there is no suitable candidate within the cut off mark for which the members of the committee suggested that it should be filled up in view of COVID-19 pandemic situation.

Further, to scrutinize the 99 nos. of merit list following ORV Act & Rule, a small sub-committee was formed under the PD, DRDA, Nabarangpur with ADM, Nabarangpur, DWO Nabarangpur, District Employment Officer Nabarangpur and DIO, NIC, Nabarangpur as the members. They have examined the list and following ORV Act & Rule, the list of 99 select candidates i.e. 33 nos. as the select candidates as per the advertisement and balance 66 nos. of candidates as waiting list have been prepared and is published hereby in **Annexure-B**.

It was discussed and decided that all the 33 nos. of select list of candidates may be invited within 7 days i.e. preferably on 21.06.2021 at 10.30 A.M at Rajiv Bhawan, DRDA Campus, Nabarangpur following COVID-19 protocol for verification of original documents and issue of engagement order those who are willing to join by furnishing under taking and other requisite.

The meeting ended with votes of thanks to the chair and members.
