ORDER

WHEAREAS, the Government of Odisha, in exercise of powers conferred U/S 2,3 and 4 of the Epidemic Disease Act,1897, have enunciated the Odisha COVID-19 Regulation 2020 for prevention and containment of COVID-19;

AND WHEREAS, the Collector & District Magistrate, Nabarangpur has been designated as the Empowered Officer and authorized to enforce and implement various measures for containment of the spread of COVID-19 diseases under Regulation 2 of the Odisha Covid-19 Regulation, 2020;

AND WHEREAS, the Government of Odisha vide Order No.64/R&DM(DM) Dated.05.01.2022 have specifically directed that congregation/ large gathering to social, religious, festivities functions will remain prohibited in the State till 1st February,2022.

NOW THEREFORE, in pursuance of Order No. 64/R&DM (DM) dated. 05.01.2022 and Order No. 177/ R& DM (DM) dated. 10.01.2022, Special Relief Commissioner & Additional Chief Secretary, Odisha to prevent transmission of Infections, I, Dr.Kamalochan Mishara, O.A.S.(SS), District Magistrate & Collector, Nabarangpur, in partial modification of all earlier orders, do hereby promulgate the following conditions/stipulations in entire jurisdiction of Nabarangpur District for its strict implementation and enforcement during the occasion of **Makar Sankranti/ Pongal (14.01.2022)**.

- **Congregation of People is prohibited;** Congregation on the occasion of celebration of Makar Sankranti/ Pongal at or near the different water bodies is purely prohibited.
- **Organisation / celebration Maker Mela is strictly prohibited.**
- All religious places/ place of worship of Nabarangpur District shall be closed for public on the day of Makar Sankranti/ Pongal/ Makar Mela. **However religious rituals are allowed with minimum priests / servitor and staff.**
- **Religious congregations/ celebrations are strictly prohibited.**
- **People are advised to perform the rituals/puja on the occasion of Makar Sankranti/ Pongal (14.01.2022) at home with family members only** with avoiding mass gathering and observing COVID-19 safety protocols.

- The stipulations/ instructions issued by the Government in Revenue & Disaster Management (DM) Department, Odisha vide Order No.177/R & DM (DM) dated. 10.01.2022 (Annexure-A) shall be strictly enforced in the entire Nabarangpur District jurisdiction.

- **Penal provisions;**

Any person violating the remedial measures/ guidelines issued by the Government in Revenue & Disaster Management (DM) Department, Odisha vide order No. 177/ R & DM (DM) dated. 10.01.2022 (Annexure-A) will be liable to be proceeded against in accordance with the provisions of Section 51 to 60 of the Disaster Management Act,2005 and COVID-19 Regulation, 2020, besides, legal action under Sec.188 of Indian Penal Code and other provisions as applicable.

ORDER

And whereas, the Government of Odisha in Revenue & Disaster Management (Disaster Management) vide its Order No.64/R&DM(DM) dt.05.01.2022, have specifically directed that congregations/ large gathering to social, religious, festivities functions will remain prohibited in the State till 1st February,2022;

Whereas, the State is passing through a critical stage of COVID-19 pandemic due to resurgence of COVID-19 in some parts of the State and it is necessary to strictly adhere to COVID-19 safety protocols for containment of spread of the infection;

And whereas, on the occasion of **Makar Sankranti/ Pongal (14.01.2022)** usually large number of people congregate at river banks/ ghats/ ponds/ sea shore or near other waterbodies to take holy bath and performing puja. **Also Makar Mela is organised/ celebrated in some districts.Such congregations have large potential for spread of COVID-19 infections;**

Now,therefore, in exercise of the powers conferred under Section 24(I) of the Disaster Management Act, 2005 read with Rule 8(1) of the Odisha Disaster Management Rules,2010, the undersigned hereby directs following restrictions ;

- (i) Congregations at river banks/ ghats/ ponds/ sea shore or near other waterbodies to take bath on the occasion of Makar Sankranti/ Pongaland on the day following shall remain prohibited throughout the State.
- (ii) Organisation / celebration Makar Mela is strictly prohibited.


- (iii) All religious places/ places of worship shall be closed for public on Makar Sankranti/ Pongal/ Makal Mela day(s). **However religious rituals are allowed with bare minimum priests/ servitors and staff.**
- (iv) Religious congregations/ celebrations are strictly prohibited.

People are advised to perform the rituals/puja on the occasion of Makar Sankranti/ Pongal (14.01.2022) at home with family members only avoiding mass gatherings and adhering to the COVID-19 safety protocols such as physical distancing, use of face mask/ covering and hand washing/ hand sanitizer.

All the District Magistrates/ Municipal Commissioners/ Commissioner of Police, Bhubaneswar-Cuttack/ Superintendents of Police shall strictly enforce the above guidelines.

Any person found violating this order shall be punished under the provision of the Disaster Management Act,2005 and other relevant laws.




