ORDER

WHEAREAS, the Government of Odisha, in exercise of powers conferred U/S 2,3 and 4 of the Epidemic Disease Act, 1897, have enunciated the Odisha COVID-19 Regulation 2020 for prevention and containment of COVID-19:

AND WHEREAS, the Collector & District Magistrate, Nabarangpur has been designated as the Empowered Officer and authorized to enforce and implement various measures for containment of the spread of COVID-19 diseases under Regulation 2 of the Odisha Covid-19 Regulation, 2020;

AND WHEREAS, the Government of Odisha vide Order No.7554 dated.29.12.2021, Order No.7592 dated.31.12.2021, Order No.64/R&DM(DM) Dated.05.01.2022 and Corrigendum Order No. 70/R&DM(DM) dated.06.01.2022, Order No. 280/R&DM dated. 12.01.2022 & 347/R&DM(DM) dated.15.01.2022 have prescribed COVID guidelines/ instruction/permissions of activities/ Stipulations for containment of COVID-19 till 5.00 AM of 1st February,2022 has been extended up to 28.02.2022.

And whereas, the State Election Commission vide their letter No.225/SEC dated.10th January.2022 has prescribed SOP/COVID-19 Guidelines to be followed while conducting General Election to PRIs, 2022.

NOW THEREFORE, in pursuance of Order No. 64/R&DM (DM) dated. 05.01.2022 and Corrigendum Order No. 70/R&DM(DM) dated.06.01.2022, Order No. 280/ R& DM (DM) dated. 12.01.2022, 347/R&DM(DM) dated.15.01.2022, No.7554 dated.29.12.2021,Order No.7592 dated.31.12.2021 & Order No. 707/ R&DM (DM) dated. 31.01.2022 of Chief Secretary, Odisha to prevent transmission of Infections, I, Dr. Kamalochan Mishara, I.A.S, District Magistrate & Collector, Nabarangpur, in partial modification of all earlier orders, do hereby promulgate the following conditions/stipulations in entire jurisdiction of Nabarangpur District for its strict implementation and enforcement prescribed for January, 2022 & General Elections to PRIs.2022 to 28th February, 2022.

Night Curfew

Night Curfew shall be imposed in all urban areas of the district from 10.00 PM to 5.00 AM every day.

Opening & Closing of Business Establishment.

All types of shops, mall shopping complexes, Markets/Haats, Cinema halls, swimming pools, entertainment complex, theatres, auditoriums, assembly hall and similar places shall remain open across the district from 5.00 AM to 10.00 PM every day.

However, during the night curfew period, the restriction shall not be permissible for supply of essentials goods and services.

Festival like Sawaraswati Puja shall be observed with all rituals in the temple and religious places without participation of devotees. Saraswati Puja will be allowed in educational institution with participation of limited number of students with adhering to the COVID-19 safety protocols such as physical distancing, use of face mask/covering and hand washing/hand sanitizer. However, no Swaraswati Puja will be allowed to be celebrated in public places other than in schools and educational institutions. People may perform the same at their home with family members only avoiding mass gatherings.

Large congregations at river banks/ghats/ponds or near other waterbodies to take bath on the occasion of Magha Saptami/ Magha Purnima and on the day following shall remain prohibited throughout the district. However, the rituals on Magha Mela/ Magha Saptami is allowed inside the temple without participation of devotees.

Considering the local condition the entry of devotees into churches/temples/mosques/religious places/ place of worship, in closed spaces, a maximum of 50 % of the hall capacity will be allowed and ensure the following norms.

- Large gathering, congregations shall be prohibited.
- The Committee members of religious institutions should adopt queue system while entry of devotee, so as to ensure social distancing.
- COVID-19 safety protocols such as physical distancing, use of face mask/covering and hand washing/ hand sanitizer must be observed.
- Regular sanitization should be made in the premises of religious places / place of worship.
- The stipulations/ instructions issued by the Government in Revenue & Disaster Management (DM) Department, Odisha vide Order No.707/R & DM (DM) dated. 31.01.2022 (Annexure-A) shall be strictly enforced in the entire Nabarangpur District jurisdiction.

All other conditions/ COVID-19 Guidelines prescribed by State Election Commission vide Letter No. 255/SEC dated. 10th January, 2022 (Annexure-I) shall be strictly followed while conducting General Election to PRIs,2022.

Penal provisions;

Any person violating the remedial measures/ guidelines issued by the Government in Revenue & Disaster Management (DM) Department, Odisha vide order No. 707/ R & DM (DM) dated, 31.01.2022 (Annexure-A) & Letter No. 255/SEC dated. 10th January,2022 of State Election Commission, Odisha (Annexure- I) will be liable to be proceeded against in accordance with the provisions of Section 51 to 60 of the Disaster Management Act,2005 and COVID-19 Regulation, 2020, besides, legal action under Sec. 188 of Indian Penal Code and other provisions as applicable.
