With reference to the subject cited above and letters under reference, I am to inform you that a daylong Apprenticeship Mela will be organized at the different Govt. ITI s. on 10th October 2022 respectively as per the list of ITI s enclosed. Further, the PMNAM will be conducted in the identified Mela Centre's in the 2nd Monday of each subsequent month (i.e each Mela Centre's coordinator will conduct the mela in every three months). If, the 2nd Monday is a holiday, then PMNAM can be held on the next working day.

The main objective of the Apprenticeship Mela is to bring the establishment/ industries and ITI Pass Outs / fresher to a single platform where all the online process like registration of establishments/ industries and trainees, vacancy creation, application to the establishments by applicants and establishments'/ industries' offer to the applicants for Apprenticeship Training, acceptance of offer by the applicants and also generation of contract bonds etc. This cooperative environment will ease the work of establishments/Industries, approving authority and also the ITI pass outs/fresher. So that ITI pass outs / fresher will get a chance to join the establishments/ industries as an apprenticeship Trainee.

Further, you are aware of the fact, the Central Govt. as well as State Govt. has prioritized the Apprenticeship Training Scheme (ATS) and giving thrust to up skill the ITI pass outs /Fresher's in the vacant training places of the establishments across the state. In this context you are requested to make all arrangements to intimate all the establishments/ industries within your jurisdiction to attend the mela on the scheduled date to engage the apprentices as per the located apprenticeship seats and also intimate the ITI pass outs/ fresher to attend with their all certificates and apprenticeship portal registration slip for performing all the online process for engagement of apprentices. The Govt. ITIs those are tagged with organizer ITIs for conducting Apprenticeship Mela is enclosed herewith for necessary action.

All the process should be done in a systematic manner using your IT lab and officials like AAA (Jr.)/ ATO/ CATO/ DEO for smooth conduct of the entire process.

Expenditures during the Mela will be made as per of the letters under reference and the required fund will be utilized out of the fund available under PL Development/IEC at respective ITI s(Mela Centre) and on production of **xerox copy bill and voucher the amount will be reimbursed from the fund available at DTE&T under Result Area-2(RA-2) (Increased Capacities of State Governments to Support ITI s and Apprenticeship Training)** . The TA/DA of the staff of tagged ITIs shall be borne by the principals of their respective ITIs.


