
Norms and Conditions for LED Wall

- I. The envelope containing the Tenders should be duly superscripted as “Quotation for LED Wall of Mondei-2022”.
- II. The sealed quotations shall be accepted as per the prescribed Performa only, Otherwise the quotation shall be rejected automatically.
- III. Place, date and time of receiving Tender -The sealed tender papers should reach the Deputy CEO,ORMAS,Zilla Parishad Office Premises, Nabarangpur - 764059 through Registered post / Speed Post only during official hours on or before 06/12/2022 time 3.00PM . The authority will not be responsible for any postal delay.
 - a. (Other means of receipt of quotation will be rejected).

- b. Quotations received after the stipulated date and time shall be liable for rejection.
- IV. **Place date and time of opening of Tender-** The quotation shall be opened on the same day i.e. on **06/12/2022 time 3.00PM** at 3.30 p.m in presence of the Bidders or their authorized representatives at Mini ZP Conference Hall , Nabarangpur
- V. **Cost of Tender Papers-** A non-fundable amount of Rs.600/- + 18% GST(Extra) i.e Rs 708/-(Seven Hundred Eight) only is to be deposited along with the tender in shape of Demand Draft in favor of Pallishree Mela, Nabarangpur drawn on any nationalized bank payable at Nabarangpur towards the cost of tender paper. The authority will not be responsible if any portion of downloaded Tender paper differ from the approved Tender paper available in the office of the Deputy CEO,ORMAS, Nabarangpur and visit the web site www.nabarangpur.nic.in

- VII. **Security Deposit-**The successful bidder has required to deposit **5% of the total value as Security Deposit** (refundable without interest) in shape of Demand Draft in favor of Pallishree Mela, Nabarangpur drawn on any nationalized bank payable at Nabarangpur at the time of execution of agreement before issuing work order. The Security Deposit shall be forfeited in case any terms and conditions of the contract are infringed or the bidder fails to make complete supply satisfactorily or complete the work in time.
- VIII. The Price offered by the firm should include all eligible taxes. .
- IX. The rates offered by the firms should be valid till completion of the **Mondei-2022**.
- X. The successful bidder has to sign an Agreement in non-judicial stamped paper minimum worth of Rs.50/- with the Deputy CEO,ORMAS and deposit the required Security Deposit within 01(one) day after finalization of the Tender prior to issue of work order by Deputy CEO,ORMAS. The work should be completed within the time frame.

The Collector-cum-Chairperson, Mondei-2022 Committee, Nabarangpur reserves the right to accept or reject any or all Tenders, full or part of the Tenders without assigning any reasons what-so-ever and no intimation will be given to the bidders. In this account no disputes will be entertained. Any dispute arises subject to Nabarangpur Jurisdiction only.

The above-described works may be modified during the mela if felt necessary and the firm should be accommodative to these minor changes. The quotation finalization authority will have the right to bifurcate and give the work to one or more firms if felt necessary and can cancel the tender without giving any reason thereof.
