The Sub-Collector Nabarangpur-cum-Chairman, RMC, Nabarangpur invites percentage rate bids in **Double Cover** system **in online mode** for the work in the table below from **the eligible contractors** registered with Govt. of Odisha / Govt. of India / C.P.W.D. / central undertaking / Railway / M.E.S. The proof of registration from the appropriate authority shall be enclosed along with the bid. If successful, the bidder who has not registered under State Government has to register under the appropriate registration authority of the State Government of Odisha in appropriate class of eligibility before award of the work as per prevalent registration norm of the State.



The Tender Paper cost and Earnest Money Deposit / Bid security of the amount specified for the work in Col. 04 above, the bidder shall make electronic payment using his / her Internet banking enabled account with designated Bank or their aggregator Bank such as SBI / ICICI / HDFC or the bidder having account in other bank can make payment using NEFT / RTGS facilities of designated banks . Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the state are required to furnish 2 % of the amount put to tender as Bid security.

5. The Bid documents will be available in the website : [www.tendersorissa.gov.in](http://www.tendersorissa.gov.in) from **11.00 AM of 09.01.2023 to 30.01.2023 up to 5.00 PM** for online bidding.
6. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
7. Bids shall be received only "on line" on or before **30.01.2023 up to 5 PM**.
8. Bids received on line shall be **opened at 11.00 AM on 31.01.2023** in the office of the RMC Nabarangpur, in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
9. The cost of bid documents as mentioned in Column 05, the bidder shall make electronic payment using his / her Internet banking enabled account with designated Bank or their aggregator Banks such as SBI / ICICI / HDFC or the bidder having account in other Bank can make payment using NEFT / RTGS facilities of designated Banks .
10. The Engineer contractor willing to avail the Exemption of EMD will submit scan copy of the affidavit to avail the exemption along with bid document and original affidavit will be submitted before opening of technical Bid. Affidavit should contain how many times such facilities have been availed by him prior to this during the current financial year. Otherwise, they will not be entitled to avail such facilities.
11. Other details can be seen in the bidding documents.
12. Bidder/firm should furnish Valid EPF Registration Certificate along with the copy of the up to date latest Challan of E.P.F.
13. The Chairman reserves the right to consider each and every point of DTCN for betterment of bidders and tender works. If required.


