- 5. The equipment shall be duly packed and insured by the supplier for transit and be dispatched at the risk of the supplier and the Head Master shall not be responsible for any loss or damage during the transit or at any time prior to inspection and approval.

Any amount payable to the Head Master hereunder shall be recovered as public demand under Orissa Public Demand Recovery Act, 1963 and shall bear 6% interest per annum till certificate for recovery is filed.
- 8. That, the supplier shall have to deposit Rs. 10,000/- (Rupees Ten Thousand) only towards Security Money Deposit only in the shape of demand Draft in favor of SAHADEV HIGH SCHOL, PONDUGUDA, Kosagumuda7 days from the issue of Purchase/ Supply Order. In case the concerned firm fails to deposit the security money no payment will be released to the supplier.
