9. That, in the event of any dispute arising in respect of the clauses of the agreement the same shall be resolved through negotiations. Alternatively the dispute shall be referred to the next higher authority or controlling officer for his decision and the same shall be binding on all parties.

10. That the "Authority" hereby further agrees to pay the contract price at the time and in the

manner prescribed in the said Terms and Conditions.

11. That in the event of any dispute that may arise it shall be settled as per the terms and conditions of the contract.

12. That this agreement is valid for 03 years from the date of execution.
