6. The bidder must quote their price in INR only as the payment will be made in Indian Currency only.
7. Tax deduction at source (TDS) shall be done as per the provision of I T Act/Rules.
8. The tender cost and EMD amount should be submitted separately in two separate Demand Draft only.
9. No bids shall be considered valid if not accompanied with Tender cost(Non-refundable) and EMD only in the shape of Demand Draft in favour of Block Development Officer, Kosagumuda payable at SBI, KOSAGUMUDA.
