## TERMS & CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

- 1. The hired vehicles, during period of contract, shall have all necessary MV documents such as:- valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up-to-date Tax payments etc. and D.L of the driver available all the times. The Department/Office hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicle or loss of life/injury made to any person or damages to any property on account of use of hired vehicle any manner whatsoever. The hire shall be responsible for all such litigation.
- 2. The hire charges to be paid after deduction of Income Tax or any other tax as applicable by law for monthly basis is final but does not include cost of Diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating Oil of engine, Gear Box & differential coolant, Tires & Tubes, Battery etc. will be borne by the bidder.
- 3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
- The vehicles shall report for duty for minimum of 25 days in a month.
- 5. The vehicle shall not be more than 3 years old from the initial registration and also in good running condition during the period of contract.
- 6. In case of breakdown for reason whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle bidder.
- 7. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
- 8. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
- Monthly hire charges of selected bidder will be paid in every succeeding month, as far as possible within fifteen days of the submission of bills by the service provider and no advance payment will
- 10. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
- 11. In case of the service provider intends to withdraw the service of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
- 12. If the bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit.
- 13. All any of the tenders (or bids) submitted can be rejected without assigning any reasons thereof. No claims whatsoever, shall be admissible for the alleged loss/damage suffered by the bidders on account of such rejection.
- 14. The application form must be signed by the vehicle owner or bidder & properly sealed &also attach all relevant documents including drafts as per the terms & condition.
- 15. The authority will not be responsible for any minor or major repair of the vehicle.
- 16. The owner of the vehicle should not be reluctant to send the vehicle to rural area as of this Project.
