Sealed quotation/tender is invited from interested reputed Travel Agencies/Tour operators or private individuals for providing 1no. of Non-AC Tiago/Swift/Bolt/Celerio Petrol driven (BS-IV or upper) vehicle, which shall conform to the terms and Conditions (Annexure-II) for official use in the District Audit Office, Local Fund Audit, Nabarangpur on monthly rent basis:

1. The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficient experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs. 5000/- shall be deposited by the indenting bidders in shape of Account Payee Bank Draft drawn in favour of District Audit Officer, Local Fund Audit, Nabarangpur and submitted along with the tender as security deposit. After completion of tender process, the amount will be refundable to unsuccessful bidders,
5. The monthly rate of hire charge be quoted separately in the general bid information(excluding fuel and lubricants)
6. The Vehicle must achieve a fuel efficiency of 17Kms per litre.

The details of the make and year of manufacture of the vehicle, registration number, mileage (Kms covered per litre ) and name of the Driver with Driving License No. and period of validity should be specially provided in the general bid information to be furnished with the Quotation/Tender (Annexure-III)
8. The Quotation completed in all respect should reach the undersigned on or before 24/07/2023 by 05.30 PM and shall be opened on dt.25.07.2023 at 04.00PM in presence of the bidders or their representatives.
