ORDER

WHEREAS, the Government of Odisha, in exercise of powers conferred u/s 2,3, and 4 of the Epidemic Disease Act,1897, have enunciated the Odisha COVID-19 Regulation 2020 for prevention and containment of COVID-19.;

AND WHEREAS, the Collector & District Magistrate, Nabarangpur has been designated as the Empowered Officer and authorized to enforce and implement various measures for containment of the spread of COVID-19 diseases under Regulation 2 of the Odisha Covid-19 Regulations,2020;

AND WHEREAS, the Government of Odisha have issued directions in connection with celebration of Rathayatra of Lord Jagannath across the State on 12th July,2021 vide Order No.3207 / R & D M (DM) dated 10.06.2021.

NOW THEREFORE, in pursuance of instructions contained vide Order No.3207 / R & D M (DM) dated 10.06.2021 of Government in Revenue & Disaster Management Department (Disaster Management), Odisha, Bhubaneswar, I, **Dr. Ajit Kumar Mishra, OAS(SS), Collector & District Magistrate, Nabarangpur** and the Empowered Officer do hereby direct to implement the following directions of Government of Odisha:-

1. **Ratha Yatra/ Car festival shall be conducted this year in Badadanda of Lord Jagannath Bije Puri and nowhere else in the State in the same manner as was done last year. However rituals relating to Ratha Yatra may be performed in temples within its premises. No chariots shall be pulled in places/ temples in the State of Odisha except Car festival/ Ratha Yatra of Lord Shee Jagannath Bije Puri”.**
2. **Besides Lord Jagannath Temple at Puri, in rest of the places, only rituals may be performed inside the temple premises.**

Any person found violating the containment measures as stipulated supra will be liable to be prosecuted against as per the provisions of section 51 to 60 of the Disaster Management Act, 2005, and COVID-19 Regulations, 2020, besides, legal action under Sec.188 of the Indian Penal Code and other legal provisions as applicable
