## **ORDER**

WHEREAS, the Government of Odisha, in exercise of powers conferred u/s 2,3, and 4 of the Epidemic Disease Act,1897 have enunciated the Odisha COVID-19 Regulation 2020 for prevention and containment of COVID-19.;

AND WHEREAS, the Collector & District Magistrate, Nabarangpur has been designated as the Empowered Officer and authorized to enforce and implement various measures for containment of the spread of COVID-19 diseases under Regulation 2 of the Odisha Covid-19 Regulations, 2020;

AND WHEREAS, **01 (ONE)** more positive cases of COVID-19 have been detected in the following areas of Nabarangpur District, it is felt necessary to make the affected area as containment zone and to restrict the public for entering into and going out from the containment zone;

NOW THEREFORE, in exercise of powers conferred under Regulation 8 the Odisha Covid-19 Regulations, 2020 read with instructions contained vide Order No.4921/R&DM(DM) dated 31.08.2021 read with Order No.5659/R&DM(DM) dated 30.09.2021 of Chief Secretary, Odisha, I, Sri Bhaskar Raito, OAS(S), Additional District Magistrate, Nabarangpur and in charge of District Magistrate & Collector, Nabarangpur and the Empowered Officer do hereby direct to implement the following directions:-

## **CONTAINMENT ZONE:**

The following areas under Nabarangpur District are hereby declared as CONTAINMENT ZONE till midnight of 21.10.2021.

- 1. During the aforesaid period, no public shall be allowed to move into or go out of containment zone. All the inhabitants in the containment zone shall strictly remain inside.
- 2. All Shops/ establishments/ markets and whatsoever nature within the containment zone shall be remain closed except supply of essential and medical requirements through various teams authorized by the District Administration.
- 3. The Officials in respect of essential services/ officials engaged in COVID-19 related duty shall show the ID cards, if demanded by the Police Authorities on duty.
- 4. During the period **till midnight of 21.10.2021**, there shall be intensive contact tracing, house-to house surveillance and other clinical interventions.



- 5. The Medical Officer-in-Charge, ANM, Asha Workers of the concerned and Authorities shall launch a massive operation and enlist all such persons who may have come in contact with the COVID-19 positive patient, assist the District Administration in intensive contact tracing and render all assistance to the District Administration as required.
- 6. In the aforesaid containment zones, the activities allowed by the Government during the period of Lockdown/ shutdown will not be permitted.
- 7. The following B.D.Os /Executive Officers of ULBs are hereby declared as Nodal Officer to ensure smooth supply of essential/ facilities in respect of Containment zones.

8. The persons under Home Isolation, in case of any emergent need, may contact the District Covid Control Room at Collectorate, Nabarangpur-dedicated Mobile **No.7077450077.** 

Further, the names and personal details of the infected persons shall not be disclosed by anybody by compromising the privacy of the person in any form.

Any person found violating the containment measures as stipulated supra will be liable to be prosecuted against as per the provisions of section 51 to 60 of the Disaster Management Act, 2005, and COVID-19 Regulations, 2020, besides, legal action under Sec.188 of the Indian Penal Code and other legal provisions as applicable.
