If successful, the bidder who has not registered under State Government, Odisha has to register under the state PWD in appropriate class of eligibility before signing of the agreement.

The Cost of tender document specified in column-05, shall be attached with the bid in sealed envelope in shape of Banker's cheque/Bank Draft only in favour of **Block Development Officer, Dabugaon payable at SBI, Dabugaon.**

**02.** Tender must accompany with 1 % EMD as mentioned in column-04, in shape of NSC/KVP/STDR/TDR / Banker's cheque dully pledged in favour of **Block Development Officer, Dabugaon payable at SBI, Dabugaon** alongwith attested copies of valid and up to date GSTIN / Pan / Tin Certificate/Contractor Licence with experience certificate (if any) of contractors from competent authority without which the Tender will be liable for rejection .Affidavit about the authentication of documents including bank guarantee must be attached with tender documents.

**03.** The contractors shall furnish a certificate along with the tender to the effect that he /she is not related to any officer in the rank of an Assistant Engineer & above in the state PR & DW dept.

**04.** Tenderers are requested to quote their **percentage** rate both in **words and figures**. The Tenderers are required to put their signature on every over writing or any correction made in the tendered rate. The tender filled in figure only but without mentioning in words shall be liable for rejection for which no tender paper cost shall be returned to the tenderers.

05. The Tender schedule alongwith bill of quantities dully filled in and all relevant papers in sealed cover will be received through registered post / speed post. Also the tenderer have to submit tender papers in the office of the undersigned to be dropped in the designated tender box .The last date of receipt of tender paper is Dt.02.06.2018 in the office hour upto 1.00PM .The tender paper will be opened in the Office of the Panchayat Samiti, Dabugaon at 11.00 AM on Dt.04.06.2018 by the undersigned in presence of the tenderers or their authorised representatives who may be present at the time of opening.

06. Telegraphic tender will not be accepted. The undersigned will not be held responsible for the postal delay if any for the delivery of the documents or non-receipt of the same in time. However no tender will be received by Fax or by E-mail.


07. Schedule caste and schedule tribe & physically handicapped tenderers will deposit EMD as 50% of the amount as mentioned in Column-04 and they will produce Caste Certificate, Physically handicapped certificate at the time of submitting tender paper.

08. In case of Engineering contractors seeking exemption of EMD of the work, are instructed to produce an affidavit regarding his / her list of works for which he / she has claimed such exemption and being avoided such works, during current financial year- 2018-19.

09. The conditional tender will not be accepted on any circumstance by the authority. *When the tenderers will quote the rate is less than the estimated cost put to tender shall have to furnish the exact amount of differential cost (i.e. estimated cost put to tender minus the quoted amount) as Additional Performance Security in shape of Demand Draft only in favour of Block Development Officer, Dabugaon payable at SBI, Dabugaon.* By the successful tenderer before execution of Agreement. *Deposit in any other shape except Demand Draft will not be entertained.* Shortfall of any required documents, drafts an EMD, tender paper is liable for rejection.

10. Where the quoted value offered in a bid, works out to an amount which is 15% less than the tendered value then the bid document shall be rejected.


