The price of the item should be quoted EXCLUSIVE of GST, insurance, packing, forwarding, freight (door delivery), installation, & warranty for 2 years. The rate should be quoted for *each item* both in figures and words. In case of difference in words and figures, words will be taken into consideration for evaluation.
- **N.B:** Valid means the certificate should be valid on or beyond the date of opening of tender (Cover-A).

#### **REJECTION OF TENDER(EIF Only)**

#### **EARNEST MONEY DEPOSIT**

- 8.1 The Earnest Money Deposit shall be Rs.25000/- only per tender. The Earnest Money Deposit will be submitted in the shape of demand Draft only in favour of CDM&PHO, NABARANGPUR from any Nationalized / Scheduled Bank payable at NABARANGPUR.
- 8.2 The EMD of the unsuccessful tenderers will be returned back without interest after placement of purchase order to the successful tenderer and EMD of successful tenderer will be returned after submission of performance security.
- 8.3 The EMD will be forfeited if the tenderer withdraws the tender or doesn't sign the contract / doesn't supply the items (in case of successful bidder) within the stipulated time period.

#### **SECURITY DEPOSIT : (Performance Security)**

- 8.1 The performance Security should be submitted in shape of Bank guarantee having validity of warranty period equal to the amount of 10% of the purchase order value of the item within 21 days of issue of the purchase order.
- 8.2 The Security Money will be returned back to the tenderer without interest after the expiry of the warranty period i.e. two years after the date of installation.
- 8.3 Security money will be forfeited if there is any violation of the tender terms and conditions.

#### **ACCEPTANCE OF TENDER AND SUPPLY CONDITIONS:**

09.1 The C.D.M.&PH O, NABARANGPUR, Odisha reserves the right to reject the tenders or to accept the tenders for the supply of the item tendered without assigning any reason thereof.

- 09.2 The C.D.M&PH.O, NABARANGPUR, Odisha will be at liberty to terminate the contract either wholly or in part without assigning any reasons thereof. The tenderers will not be entitled to any compensation whatsoever for such termination.
- 09.3 The supply should be completed within 60 days from the date of issue of purchase order unless otherwise specified. If no supply is received even after 60 days or 88 days with liquidated damage from the date of issue of the purchase orders from the C.D.M.O, NABARANGPUR, such orders will stand cancelled automatically without further notice. Penalties shall also thereafter be applied to the tenderer as specified in clause. The approved firm shall also suffer forfeiture of the EMD and Security Deposit.
- 10.4 If the approved supplier fails to execute the supply within the stipulated time, the C.D.M.O, NABARANGPUR, is empowered to purchase the same items from  $L_2$  or  $L_3$  tenderer if they match the  $L_1$  rate.
- 11.5 The C.D.M.O, NABARANGPUR, Odisha or his authorised representative (s) has the right to inspect the factory of those company who have quoted for the tender, before accepting the rate quoted by them or before releasing any purchase order (s) or at any point of time during the validity period of tender and has also the right to reject the tender or terminate / cancel the orders issued or not to reorder based on the facts brought out during such inspections.

#### **TERMS OF PAYMENT:**

- 12.1 No advance payments towards cost of medical equipments or turnkey job will be made to the tenderer.
- 13.2 90% of the cost of the equipment + 100% tax shall be paid to the supplier on receipt of the stock entry certificate, installation and demonstration of the item from the consignee. The balance 10% of the payment of equipment will only be made after receipt of certificate on working status of the equipment from the consignee after 6 weeks of installation and commissioning of the equipment for which, the supplier has to raise two bills (A) one for 90% of the cost of the equipment + 100% taxes (B) the other for balance 10% of the cost of the equipment.

13.3 No claims shall be made against the C.D.M.&P H O, NABARANGPUR, Odisha in respect of interest on earnest money deposit or security deposit or any delayed payment or any other deposit.

13.4 Payments in shape of Draft / Pay Order will preferably be dispatched to the supplier by Registered post with A.D or e-payment / on-line transfer or may be handed over to the authorized person of the supplier.

#### **PENALTIES:**

21.1 If the successful tenderer fails to deposit the required security within the time specified or withdraws his tender after acceptance of his tender owing to any other reasons or unable to undertake the contract, his contract will be cancelled and the earnest money deposit & security deposit submitted by him along with his tender shall stand forfeited by the C.D.M&PH.O, NABARANGPUR, Odisha by reasons of such breach, such as failure to supply / delayed supply.
