- 8. Bids received on line shall be opened at 11.00 AM on 03/07/2018 in the office of the R.M.C. Nabarangpur in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- The original affidavit regarding authentication of the documents and all other documents in original shall be furnished before the TEC at the time of Opening of Tender for verification.
