GENERAL TERM AND CONDITIONS FOR SOLAR LIGHT

1. The luminaire manufacturer must be MNRE Approved channel partner and with SP1A/SP, IB/SP IC Solar grading only.
2. The total system warranty of the complete system should be 5 years and above.
3. The Dimming of lighting system should be more than 50%.
4. The luminaire Company must be a manufacturer of LED luminaires & charge controller. The manufacturer should have in house lighting design center and Photometry lab approved NABL.
5. The bidder must submit LM79 report of the luminaire to justify the lumen output of the luminaire should be 110 lm/watt or more.
6. The luminaire manufacturer should have a registered office and service set up with Toll free number to provide immediate after sales service in the state.
7. PV Modules and DC street Light Luminaire should be of the same brand.
8. The brand name and Logo of the solar lighting company should appear on the PV Modules and should be embossed on DC street light luminaires.
9. The PV modules should be TUV certified with IEC 61215 & IEC 61730 certifications. All these certificates should be in the name of Luminaire manufacturer.
10. The Warranty on the complete lighting system will be for 60 months from the date of supply. The luminaires manufacturer should submit a letter on their letter head by mentioning that they will supply the solar street light system with pole and with all accessories in complete manner confirming said warranty and will provide after sales services to rectify/replace their materials against manufacturing defects under the warranty period as mentioned in the tender.

ELIGIBILITY CRITERIA FOR PARTICIPATION IN TENDER :

1. The rate is inclusive of all the taxes & cost of transportation up to points as per list enclosed. The Tenderers should submit their tender with valid sales tax clearance/ Specific item of Tender should be mentioned in Registration Certificate /TIN No/ up to date VAT clearance certificate up to **31/3/2019/** Dealership Certificate and PAN CARD/Copy of Income Tax return for last three years/Xerox copy of Pass Book account the name of Unit.
2. The prospective bidder shall have satisfactory completed as a prime agency during the last 5(five) years prior to the date of issue of this Notice at least one work of similar nature under authority of State/Central Govt.
3. The prospective bidders shall have in their full time engagement experienced technical personnel, with the sufficient knowledge of PERT/CPM, the minimum being one Civil Engineering Diploma holder (Authenticated documents in respect of qualification and engagement shall be furnished for Technical Evaluation).
4. The prospective bidders should own or arrange through lease hold agreement the required plant and machineries of prescribed specifications as shown above. Conclusive proof of ownership (Tax Invoice, Way Bill, Delivery Challan, and Incorporation in the Balance Sheet as fixed asset) for each plant and machineries in working condition shall have to be submitted. Present location of installation of main plant and machineries as mentioned in specified format has also to be disclosed.
5. **Joint Ventures will not be allowed.**
6. The partnership firm shall furnish the registered partnership deed and the company shall furnish the Article of Association and Memorandum.
7. Agencies shall have to arrange required land for installation of plant & machineries, storing of materials, labour shed, laboratory etc. at their own cost and responsibility nearest to the work site.

8. Constructional Labour Welfare Cess @ 1.00% of cost of construction will be deducted from every bill of the selected agency, GST & all other statutory dues will have to be borne by the unit and the rate in the schedule of rate inclusive of all the Taxes.
9. **No Mobilization advance and Secured Advance will be allowed.**
10. There shall be no provision of Arbitration.
11. Regarding deduction against GST, all formalities will be made as per Govt. Norms.
12. Quantity depends on the rate quoted.
13. The tender paper in sealed cover must be accompanied by required Tender Cost in favour of the Project Administrator, ITDA, Nabarangpur in shape of Bank Draft/Banker Cheque payable at SBI, Nabarangpur, which will be refunded immediately to the unsuccessful Tenderers after finalization of Tender and to the Successful Tenderers after full supply of procurement items.
14. The Tender paper is to be addressed to the Project Administrator, ITDA, Nabarangpur and on the top of the cover should be super scribed "**Tender paper for Installation of Solar Street light at various place of Nabarangpur District in the State of Odisha**".
15. **The successful Tenderers will have to deposit Security amount 5% of the total cost of articles, in shape of Bank Draft in favour of Project Administrator, ITDA, Nabarangpur, payable at SBI, Nabarangpur.**
16. All the procured items should be supplied **within 30-days** from the date of placement of order. All equipment should be delivered in full and good conditions to project point and in no case part supply will be accepted. The Successful Unit/Firm should submit VAT Clearance up to 31/03/2019 during time of submission of Invoice Bill with Delivery Challan.
17. The Supplier should supply the products having specific company logo in each and every item as specified.
18. If the supplier fails to supply the articles with in stipulated period, the order will stand automatically cancelled and the EMD & security money will be forfeited to Government.
19. The successful tenderers should replace any damage materials or if arose any incorrect size/Specification of specified item should replace immediately to concerned R.Os.
20. During finalization of Tender by Dist. Purchase Committee to place of supply order to lowest Price quoted unit with observing quality of Materials.
21. The authority reserves the right to reject any or all Tender without assigning any reasons thereof.

22. Qualification Criteria :

The Tender Inviting & Accepting Authority will determine the eligibility of each bidder, the bidders shall have to meet all the minimum criteria regarding:-

- a) Financial Capacity.
- b) Technical Capacity comprising of personnel & equipment capability.
- c) Experience.

The eligibility of a bidder will be ascertained on the basis of the self-attested documents in support of the minimum criteria as mentioned a,b,c above and the declaration executed through prescribed affidavit in non-Judicial stamp paper of appropriate value duly notarized. If any document submitted by the bidder is either manufacture or false, in such cases the eligibility of the bidder/ Tenderer will be out rightly rejected at any state without any prejudice with forfeiture of E.M.D.


