# Project Implementing Agencies(PIA) for Vocational Training:

The Project Implementing Agencies(PIAs) shall be engaged for imparting the trainings to the identified students & the PIA shall be selected through a bidding process.

### The role of PIA includes:

- Preparation and submission of the individual school wise Training plan by identifying the opportunity for employability.
- Counseling of the students and drawing up tread wise student list.
- Developing a training curriculum/module for each Trade.
- Conducting Vocational Training for the students in the identified 07( Seven) nos. of Schools.
- > Suggesting the training kit to be supplied to the students by the DWO.
- > Ensuring quality of the training by deploying qualified and experienced Resource Persons.
- ➤ Each Resource Person identified for a particular trade should impart training for all the Seven High Schools in Nabarangpur District.
- > Regular counseling of the trainees to ensure that they participate and complete the training programme.
- Submission of Monthly Progress Report to the concerned Headmaster/Headmistress & DWO.
- Preparing and submitting the programme completion report by highlighting the outcomes of the training.
