Sealed tenders should reach in the office of the CDM&PHO NABARANGPUR, Odisha, at 5 **P.M on dt 13.08.2019**. Tender received beyond the aforesaid time & date will be returned to the sender unopened. All the tender papers must be submitted by **Regd. Post/ Speed Post** only.

- 1.1 The sealed tenders submitted by the Tenderer will be opened by the CDM&PHO NABARANGPUR, Odisha in his office on dt 14.08.2019 at 11A.M. The Tenderer or his duly authorized representatives are allowed to be present during opening of the tenders if they so like. If the tenderer or his authorized representative fails to be present at the time of opening of the tender that will not bar the authority from opening the tender or carrying on the subsequent tendering process.
- 1.2 Reputed Firms / Agencies having appropriate & proper valid registration are eligible to participate in the tender and quote for all the items.

Terms of Reference for Outsourced Agency

Draft Contract

The" terms of reference "to be prepared by specific public health institutions should have the following points, apart from other details based on the requirement of the specific public health institution.

1. Invitation to Bid:

The DHH Nabarangpur functioning under Department of Health and Family Welfare, Government of Odisha, invites tender from the eligible registered diet preparation and catering firm having valid GSTIN certificate, Labor license & Food license to prepare and distribute therapeutic and non-therapeutic diet(cooked & dry both) for DHH Nabarangpur . Women Self Help Groups [SHGs] can also apply. The bid is invited as per the decision of Department of Health and Family Welfare for outsource the diet preparation and its services to the patients on annual contract basis to the eligible firms.

2. Introduction:

- 2.1 This bid is open to agency/agencies and women Self Help Groups [SHGs] satisfying the criteria laid down in this bid document who have the required operational experience in dietary services and its management.
- 2.2 The health institution will select an agency, in accordance with the method of selection specified in this bid document
- 2.3 The work details have been mentioned in this bid document for the reference of the bidder and preparing the bid document accordingly.
- 2.4 Interested Bidders are invited to submit "Technical Bid" & "Financial Bid for providing services required for supply of diet (cooked & dry) related services as per the standard norm and procedure of the Government of Odisha for daily Diet Menu/ Chart consisting of therapeutic & non therapeutic value.

- 2.5 The hospital administration is not bound to accept any bid/s, and reserves the right to terminate the selection process at any time prior to the award of the contract, without showing any reason thereby. Keeping the greater interest of in-door patients in mind, the contract of the selected / awarded agency may also be terminated by the hospital administration if prescribed quality standards are not adhered to. However, hospital administration is not bound to show any reason for cancellation of the bidding process or termination of contract.
- 2.6 The bidder is expected to examine all instructions, forms, terms, specifications, and other information in the bid / tender document. Failure to furnish all information required for bidding or to submit the bid it will be rejected.
- 2.7 The bidder would bear all costs in connection with the preparation of the bid and its submission. The hospital administration would not bear any bid preparation cost and cost for submission of the bid.
- 2.8 In case of requirement, the hospital administration would provide required information, based on the request of the bidder, which is necessary for preparing the bid.

2.9 This bid / tender does not commit to award the contract or to engage any agency through negotiations. Further, no reimbursable cost may be incurred in anticipation of award and in such cases; hospital administration would not be responsible to bear such costs incurred by the bidder

3. Eligibility Criteria:

- 3.1 The bidder should have a registered / operating office in the district with staff strength not less than 4 members. The bidder / outsourced agency should have relevant experience in diet preparation, diet service and overall management of diet in hospital or similar Government and/or non-Government establishments.
- 3.2 The bidder should have a minimum of 3(three) years experience in diet preparation and its supply / services in public or private institutions.
- 3.3 If the agency has provided similar type of services in any public /private health institution/s, it would be the added advantage. The agency should provide required evidence in this regard.
- 3.4 The agency must be a registered body under appropriate law of the State or central Government and having the documentary evidence in this regard.
- 3.5 In case of Women SHGs, the hospital administration is free to take suitable decision and may consider relaxation in the overall eligibility criteria.
- 3.6 The bidder or the personnel employed by him should not have any criminal background.

3.7 The bidder have to produce an up to date food license certificate from the FOOD & SAFTY **Officer.**.

4. Number of Bids:

- 4.1 The bidder can apply only one bid in this tendering / bidding process.
- **4.2** In case if a single bidder submits multiple bids for one item, either singly or in collaboration, all bids, except one that is most suitable as per the decision of the tender committee.

5. Bid Validity:

The bid would remain valid for a period of 120 days from the date of submission.

6. Tenure of Contract:

The selected agency / bidder would be initially contracted for a period of **one year from the date of award of the contract**. Based on the performance and feedback from different stakeholders, the contract may be renewed for another one year.

7. Payment Schedule:

7.1 The agency would be paid once in a month based on the case load and number of meals supplied. The number of diets prepared during lunch would be considered as the benchmark for calculation of number of patients /days or any such norms that is suggested and agreed upon mutually by the hospital administration and the outsourced agency / bidder.

7.2 Hereby, it is mandatory for the health institution to pay the dues to the agency within the first seven working days of each month, based on the submitted bills / vouchers in the prescribed format. The hospital administration, Matron & hospital manager would verify the bills, vouchers and other supporting and do the needful for payment of the dues within seven working days of submission of bills / vouchers / supporting documents.

7.3 No claim shall be made against the first party in respect of interest on EMD & SD.

8. Tender Fee:

All Bidders are required to pay **Rs. 500 (Rupees Five Hundred only)** towards Tender Fees in the form of Demand Draft drawn in favour of the CDM&PHO NABARANGPUR. The Tender Fee is Non-Refundable and cannot be claimed by the tendering agency.

9. Tender Processing Fee:

All Bidders are required to pay **Rs. 500** (**Rupees Five Hundred only**) towards Tender Processing Fees in the form of Demand Draft drawn in favour of the CDM&PHO NABARANGPUR. The Tender Processing Fee is Non-Refundable and cannot be claimed by the tendering agency.

10. Security deposit:

The agency, after selection, has to deposit **security money in shape of bank gurantee** amounting to 5% of the total reimbursable amount in a year within 15 days of signing the contract. It would remain valid initially till the end of the initial contract period and will be extended if the contract gets extension.

11. Last Date for Submission of Bid:

The bid would be submitted in an appropriate form in a sealed envelope on or before dated **13.08.2019 at 5.00 P.M.** The bids received after the due date and time would not be accepted and liable for rejection.

12. Bid Withdrawal:

After the submission of the bid, if so wished by the bidder, s/he may withdraw the bid with a payment of non-refundable amount of **Rs.500/-(Five Hundred only**) towards withdrawal processing fee. In case of single tender received the decision will be taken as per bylaw for tendering process.

13. Right to Accept or Reject the Bid:

The administration of the CDM&PHO Nabarangpur reserves the right to accept or reject any Bid and the bidding process and reject all such bids in part / full at any time prior to award of contract, without showing any reason there by.

14. **Opening of Bids:**

The bids would be opened on the specified date, time and venue in the presence of the persons nominated by the hospital administration and in presence of the bidders. The bidders would be requested to attend the bid opening and all present bidders shall put their signature on the bid as an evidencing of their attendance.

15. Bid Evaluation Criteria:

The bids would be evaluated on cost and quality basis i.e. the cost quoted by the bidder for supply of diet (cooked & dry) to be supplied to the patients in the hospital. The lowest quoted bidder adhering to the specified quality would be awarded the contract.

16. Disqualification:

The Tender Committee of the DHH NABARANGPUR seeking this bid, reserves under its sole discretion to disqualify any bid document if;

- 1. The bidder submit the bid after the last date of submission of bid;
- 2. The bid document does not have the proof of similar nature of work in public/private health institutions or any such establishments of Government or Private agency.
- 3. Registration certificate [photo copy] is not attached to the bid document.
- 4. The bidder is blacklisted by any Govt. agency [declaration in this regard is to be given by the bidder]
- 5. No attachment of bank draft towards processing fee of Rs.500/- and cost of the bid document amounting to Rs.500/-. Bid documents not signed on each page by the bidder.

17. Adequacy of Information:

Once the bidder submits the bid document signed on all pages it will be assumed that the bidder have carefully examined the bid document to his / her entire satisfaction. Once the agency is selected on the basis of its submitted bid, the agency would be responsible to fulfill his/her obligation as per the submitted bid.

19. Clarification on the Bid:

20. General Information to Bidder.

- 20.1 The successful bidder [also referred here as the agency or outsourced agency would operate in the campus of the DHH Nabarangpur and required basic infrastructure would be provided by the health institution to facilitate the smooth operation of the agency.
- 20.2 The agency would be abided by the cost and quality norms/standards as mentioned in the bid, diet guidelines and / or others communicated to them from time to time by the RKS DHH Nabarangpur .
- 20.3 The agency would recruit required number of staff for cooking and serving so that diet can be supplied to the in-door patients in time.
- 20.4 The agency would take up free health check-up of the cooking and serving staff from time to time, at least once in three months.
- 20.5 The maintenance of kitchen and equipments or rooms would be the responsibility of the agency and the agency should ensure that proper care is taken in this regard.
- 20.6 The agency would prepare and supply diet adhering to the quality norms specified by the health institution. The agency should also prepare different types of diet as per the indent placed by the health institution keeping in mind the diet requirement of different category of patients.
- 20.7 The agency would be responsible for procurement of different items required for preparing diet and storing it properly. The health institution would not be responsible for any loss of procured items.
- 20.8 Perishable items would be supplied / procured on daily basis and for that supplier / suppliers would be identified jointly by the designated person of the health institution and the outsourced agency.
- 20.9 The health institution would have the right to monitor the quality of items purchased and used in the diet preparation process.

- 20.10 The agency would manage kitchen waste in a scientific manner with due consultation with the concerned hospital administration.
- 20.11 At any point of time i.e. during procurement of raw materials, processing, preparation of diet, serving the diet to the patients and cleaning the utensils / instruments, the dietician and/or any person from the health institution can visit and interact with concerned person. The agency should not have any restriction to this; rather the agency would facilitate such process to improve the service quality.
- 20.12 The agency would prepare and update the accounts details and maintain other related documents that are required for reimbursement of the expenses on monthly basis. In case of incomplete documents, the hospital administration would not reimburse the incurred cost. The documents to be prepared should be supplied by the health institution before hand and maintained by the agency on daily basis. The financial and non-financial documents would be subject to audit.
- 20.13 The behavior of the serving staff of the agency towards the patients & hospital officials should be conducive and disciplinary action would be taken by the hospital administration, in consultation with the concerned agency, against the person/s violating the behavioral norm. The authority will ask the agency to withdraw any of his/her worker/s from the hospital, without assigning any reason.
- 20.14 The agency would be responsible to make alternative arrangements in cases of situations such as staff strike, local strike [Bandh/ Hartal] etc. ensuring that the patients get diet in the appropriate time.
- 20.15 The agency would be abided by different Government notification, circulars, written instructions etc. published from time to time with regard to the subject. In case of requirement, the hospital administration would provide required clarity to the agency on the related notification, circular etc.

20.16 For any grievance, the agency would approach to the designated person of the CDM&PHO NABARANGPUR and appraise them in written about the problem. It is the responsibility of the CDM&PHO NABARANGPUR to comply with the grievance and solve it within a maximum of one month time and decision should be communicated to the agency in the written form.
20.17 Any dispute arising in the process of managing the diet preparation and supply, both the party i.e. the outsourced agency and the hospital administration would discuss and take

appropriate decision that is mutually agreeable.

- 20.18 The hospital administration reserves the right to cancel or renew the contract of the outsourced agency with prior notification of 30 days without assigning any reason thereof. The same condition is also applicable for the outsourced agency in case the agency wants to quit its service.
- 20.19 The outsourced agency would provide uniform embedded with its logo to all the staff recruited by the agency. The agency would ensure that the recruited staff attend their duty with clean uniform and keeping themselves neat and clean while on duty.
- 20.20 Photo identity card (duly signed by the agency) be provided by him/ her during the period of the work.
- 20.21 All men/manpower to be engaged by the agency should be covered under the statutory Government regulation framed from time to time relating Labour Law like work man compensation act, insurance etc, it will be the sole responsibility of the agency to take care of the safety measure for his/her employees. In case of any accident so occurs during process of cooking by fuel, CDM&PHO NABARANGPUR will not be a party to any kind of dispute & legal matter will be solved by the agency.

20.22 Suitable space to store the raw materials shall be provided by the DMO(MS) cum Superitendent DHH Nabarangpur .

- 20.23 Tenders should be typed neatly without any over writing. In case of any correction/over writing in the tender, the same should invariably be attested by full signature with date before submission.
- 20.24 The price quoted by the bidder shall not in any case exceed **Rs 85/-(rupees Eighty only)for** General patient and **Rs 95/- (Rupees Ninty Five only)for TB ,Cancer & Burn** patient per day per patient& 75 for Liquid& Dry food respectively.

20.25 The diet carrying trolleys, kitchen space with electricity & water shall be provided by the DMO(MS) cum Superitendent DHH Nabarangpur to facilitate cooking by using fuel not by using heater.

- 20.26 Sample diet Menu for that particular day should be sent to Matron / Spl. in H.A. / Supdt / Dy supdt / H.M. for that day for testing before distribution to the patients of this hospital. The tenderer should collect indent for supply of diet to the in patients from the dietician.
- 20.27 If the selected tenderer fails to supply the necessary requirements of diet to the patients in time the required items will be purchased from open market as per the prevailing rate for regular supply to the indoor patients & the differential cost in any of the items so purchased will be deducted from his/her diet bill.

20.28 The earnest money deposit shall be equal to Rs.30,000/- (Thirty thousand) only for supply of diet(Cooked & Dry) on the tender which will be paid in form of Demand Draft drawn in favour of CDM&PHO NABARANGPUR which will be sent with tender paper. EMD in other form i.e. Cheque / Cash etc. will not be accepted .

ARTICLES OF AGREEMENT FOR SUPPLY OF DIET (COOKED & DRY) TO THE PATIENTS OF CAPITAL HOSPITAL, BHUBANESWAR.

Agreement between CDM&PHO NABARANGPUR and ______ (Name & Address of The Agency) for supply of Diet (cooked & dry) to indoor patients of RKS DHH Nabarangpur District-Nabarangpur

This agreement made on this day of ______ BETWEEN the CDM&PHO NABARANGPUR represented by its Member Secretary, RKS DHH Nabarangpur, District -NABARANGPUR . (here-in-after called the The Authority which expression shall unless excluded by or repugnant to the context, be deemed to include their successors in office) of the one part AND the Proprietor, _____ (Name & address of agency) here-in-after called The Agency which expression shall unless excluded by or repugnant to the context, be deemed to include his surviving or other persons entitled to share including his heirs, executors, administrators, representatives, Assignees or Successors in THE office) second party.

AND WHEREAS the Authority desirous of executing the work of diet preparation and distribution to the indoor patients of DHH Nabarangpur at their bedsides.

AND WHEREAS the agency has offered to execute the above work for the period of one year from ______ to _____ AND WHEREAS the Authority has accepted the offer for an

amount of **Rs._____** (**Rupees ______**) only per month which includes diet preparation from his/her own procured raw materials & catering to the bedside of the patients.

AND WHEREAS both the Parties agree that the above payment will be made on monthly basis i.e. on the first week of every month by crossed account payee cheque.

AND WHEREAS the Parties hereto are desirous and have found it necessary and expedient to record the terms and conditions in respect of the aforesaid work into an agreement.

NOW THESE PRESENTS WITNESS and it is hereby and in between the Parties hereto as follows:

The Agency shall continue the aforesaid work for a period of one year starting from ______ to

_____ and continuation of the same will be based on satisfactory performance of assignment.

The Agency i.e. the 2_{nd} Party is required to give 5% of the total reimbursable amount in a year to CDM&PHO Nabarangpur as performance security which will be refunded on satisfactory completion of the work after the contract period.

Price escalation in future, if any, will not be paid in case of rise in prices to the service provider except any statutory increase.

The Agency should prepare Diet with raw materials purchased by him/her for the patients Capital Hospital, Bhubaneswar as per the following terms & condition.

- □ All the workers engaged by the Agency in the Capital Hospital, Bhubaneswar shall have the uniform.
- All staffs of the Agency shall bear photo identity card during the period of work, which shall be duly signed by the Competent Authority ______ (Agency).
- □ All workmen/manpower to be engaged by the contractor should be covered under the statutory government regulation framed from time to time.
- □ CDM&PHO NABARANGPUR may request the Agency to withdraw any of his workers from the hospital without assigning any reason, within 24 hours prior intimation.
- □ The agency will abide by all the rules and regulations relating to labour laws, accident, workmen compensation act, workmen insurance etc. This will be the sole responsibility of the Agency. CDM&PHO NABARANGPUR will not be a party at any stage to any kind of dispute relating to the above. In case any liability arises due to non-performance by the Agency, under no circumstances CDM&PHO Nabarangpur will be liable for the same.

- Any damage/pilferage to DHH Nabarangpur property due to mishandling, carelessness of the Agency or his worker will be recovered from the Agency s bill and all materials issued to Agency shall be the sole responsibility of the Agency during the period of the contract.
- □ Agency should depute a qualified and dedicated staff to manage the work, who will coordinate in work execution activities and interact with the Hospiatl Matron/HM DHH Nabarangpur representatives, responsible for supervision of the work.
- □ The Diet preparation should be made in the hospital kitchen Section by making necessary arrangement under proper supervision of HM.
- All the employees will have to be covered under insurance against any personal accident and Ditrict Medical Officer(MS) will not be liable for payment of any compensation on that account.
- During execution of work, the Agency should follow all standard norm of safety measures/precautions to avoid accidents/damages to manpower, Kitchen tools and buildings etc. On non-adherence to this clause, suitable fines, as decided by the CDM&PHO NABARANGPUR will be imposed.
- □ The Agency should supply the diet (Cooked &dry) for breakfast, Lunch & Dinner to indoor patients of DHH NABARANGPUR, at the bedside of the patients in presence of staff nurse/in-charge of the concern ward as per the Diet Menu with required nutritive value in accordance with the specified rates mentioned in TOR.
- The Diet (Cooked &dry) for breakfast, Lunch & Dinner should be served to the indoor patients of the DHH NABARANGPUR at their bedsides in different wards in the schedule time i.e. breakfast between 8 a.m to 9 a.m, Lunch between 1 p.m. to 2 p.m. & Dinner between 8 p.m to 9 p.m.by making arrangement in all respect. Any complain in this regards will not be reported from patients side.

The Authority shall have the right to inspect the said work during the cooking period and the right to issue such order and direction to the Agency as may be considered necessary in conformity with this agreement. The Agency shall ensure that such orders are complied with.

The Agency shall not entrust the work given as mentioned under this agreement by the Authority to any other Party or Parties in the contract period.

The biological waste so produced shall be disposed off inside the hospital as per order of the competent authority.

Any matter not covered by this agreement will be mutually settled by the Parties to this agreement. In case of disputes between the Parties the decision of the Collector, Nabarangpur will be final and binding or the disputes may be settled by a remittal Arbitrator chosen by the Parties.

In case of any dispute arising between the parties, cases have to be filed only within the jurisdiction of Nabarangpur.

From time to time the quality and other obligations will be monitored by a designated committee member .The report will be discussed in RKS EB/GB meeting regarding deficiency if any.

Unsatisfactory performance if any, detected a penalty of 5% of the payment will be deducted from the monthly payment. Repeated irregularity/ unsatisfactory performance shall entity in termination of agreement.

The second party ensure the following

- □ **Bread:-** Sliced breads should be fresh and free from fungal infection.
- □ **Roti:-** Good quality and fresh atta should be used to prepare the roti.
- □ **Dal:-** Good quality arhar & mung dals are to be used and quantity should strictly follow as per the diet schedule.
- □ Vegetables:- All vegetables should be fresh far from blemishes and best quality. Quality of all types of vegetables must be good and quantity should be strictly follow the diet schedule to maintain the prescribed nutritive value.
- □ **For Gravy:-** Onion, Garlic, Ginger and Tomato will be used for gravy. No chili powder will be used in the curry. Any flavoring agent (branded one) may be used if required.
- □ Oil: Rich in Monounsaturated fatty acid and poly unsaturated fatty acid of reputed brand.
- □ **Fish:-** Fish should be fresh and not less than 1.5 KG weight. Only Rohi and Bhakura should be given.
- □ **Chicken:-** Chicken pieces should be free from head, neck, liver and gizzard.
- □ **Biscuit**:- Britannia / parle -G

N.B:- All items shall have to be prepared after proper dressing cleaning and washing and cooking in hygienic manner.

- 24.2 The EMD *of* the unsuccessful bidders will be returned back soon after publication *of* the approved list without interest. The EMD of the successful tenderer will be returned back only after submission of the Bank Guarantee / Performance Security.
- 24.3 The EMD will be forfeited, if the tenderer withdraws the tender after publication *of* approved list *or* fails / refuses to execute the work order.

SECURITY DEPOSIT / PERFORMANCE SECURITY:

25.1 The Security Money (Bank Guarantee) will be returned back to the tenderer after the expiry of agreement period / in case of renewal agreed by both parties the bank guaranty needs to be revalidated for the renewal period.

AGREEMENT

26.1 The tenderer whose tender is accepted shall execute an agreement on non-judicial stamp paper worth of Rs. 20/- (stamp duty to be paid by the tenderer) with the CDM&PHO NABARANGPUR within 7 days from the date of receipt of work order failing which the Director has the right to cancel the work order. The specimen form of agreement will be supplied by the CDM&PHO NABARANGPUR.

TENDER CONDITIONS:

27.1 Tenders should be typewritten / computerized and every correction in the tender should invariably be attested by full signature of the tenderer with date before submission, failing which the tender will be ineligible for further consideration. Corrections done with correcting fluid should also be duly attested.

- 27.2 The rates should be quoted in Indian currency only both in words & figures against each item. However, the rates quoted in words shall prevail if there is difference between words and figure. The tenderer shall not quote his own rates for any item other than the item specified in this list. Price quoted in any other currency will be rejected.
- 27.3 The price quoted by the tenderer shall not in any case, exceed -, Rs. 85/- Rs 75/& Rs. 95/-, for general Patients, Paediatric/Dry diet & for TB, Cancer & Burn Patients respectively per day per patient.
- 27.4 The rates quoted and accepted will be binding on the tenderer for the stipulated period and on no account any increase in the price will be entertained till the completion of this agreement tender period.
- 27.5 No tenderer shall be allowed at any time on any ground whatsoever to claim revision of or modification in the rates quoted by him due to clerical or typographical error, committed by the tenderer in the tender forms shall not be considered after opening the tenders. Conditions such as "SUBJECT TO AVAILABILITY" will not be considered under any circumstance and the tenders those who have given such conditions shall be treated as incomplete and for that reason, shall be summarily rejected.
- 27.7 The terms and conditions and the quoted price of the tenders shall remain valid for a period of 12 months from the date of agreement or the extended period for another one year if any whichever is later.
- 27.8 If any information or documents furnished by the tenderer along with the tender papers are found to be misleading or incorrect at any stage, steps will be taken to blacklist the said agency for three years & legal actions will be taken against the agency as per law.
- 27.10 In the event of the date being declared as a holiday for Govt. of Orissa the due date of submission of bids and opening of bids will be the following working day at the scheduled time & place.

GOVERNING LANGUAGE:

28.1 The contract shall be written in English language. English language version of the contract shall govern its interpretation. All correspondence and other documents pertaining to the contract which are exchanged by the parties shall be written in English.

ACCEPTANCE OF TENDER:

- 29.1 The CDM&PHO Nabarangpur, Odisha reserves the right to reject the tenders or to accept the tenders for supply of diet (cooked & dry) without assigning any reason thereof.
- 29.2 The CDM&PHO NABARANGPUR, Odisha will be at liberty to terminate without assigning any reasons the contract.

PENALTIES:

- 30.1 If the successful tenderer fails to execute the agreement or deposit the required security amount within the specified time or withdraws his tender after acceptance of his tender owing to any other reasons/ he is unable to undertake the contract, his contract will be cancelled and the **Earnest Money Deposit** deposited by him with the tender will be forfeited and he will also be liable for all losses sustained by the CDM&PHO Nabarangpur, Odisha, by reasons of such breach, such as fail to execute the work delayed in execute the order & the liability to pay any difference between the prices accepted by him and those ultimately paid for the work done by other. Such damages shall be assessed by the Authority, whose decision is final & binding in the matter.
- 30.2 Non performance of tender terms & conditions will disqualify a agency to participate in the tender for the next three years.
- 30.3 In the event of any dispute arising out of the tender, such disputes would be subject to the jurisdiction of the Civil Court, Nabarangpur.
- 30.4 Unsatisfactory of performance if any detected a penalty of 5 % proportionately payment shall be deducted from the monthly payment. Repeated irregularity unsatisfactory performance shall entail in termination of agreement.
