

The envelope must be super scribed as "Tender for Hiring of Vehicles for RMC, Nabrangpur. The tender shall confirm to the terms & conditions of the bidding document.

(A) GENERAL INFORMATION

- 1. The vehicle must be in Road Worthy condition, shall not be more than 03(three) years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
- 2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle. Salary of the driver shall be paid by the owner.
- 3. The Driver should be well behaved, gentle and obedient in nature.
- 4. The Selected bidder shall have to execute agreement with the RMC, Nabarangpur indicating the terms and conditions.
- 5. Payment of hire charges shall be made on monthly basis after submission of Log Book of the vehicle duly certified by the officer using the vehicle along with the bill. Necessary TDS (I.T) as prescribed shall be deducted from the monthly bill.
- 6. The vehicle will remain at the disposal of the RMC, Nabarangpur.
- 7. Paper Cost and Earnest Money Deposit (EMD): A Sum of Rs.500.00 (Rupees Five hundred) Only toward paper cost and Rs.5,000.00(Rupees Five thousand) only towards EMD respectively shall be deposited by the intending bidders in shape of Demand Draft drawn in favour of the RMC, Nabarangpur and submitted along with the tender towards Paper cost and EMD. After completion of tender process, the EMD amount without interest of unsuccessful bidder will be refunded, BID submitted without Paper Cost and EMD will summarily rejected.
- 8. All taxes/Renewal of Fitness Certificate, Insurance and Permit as per Motor Vehicle Act shall be borne by the owner.
- 9. The Vehicle must achieve a fuel efficiency of **12(Twelve)** Kms per litre in case of monthly vehicle.
- 10. The details of the make and year of manufacture of the vehicle, registration number, mileage (KMs covered per litre) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the tender (Annexure-I)
- 11. The interested Service Providers may submit the sealed tender document complete in all respects along with Paper Cost and EMD and other requisite documents as per Annexure-II on or before 30th March' 2020 addressed to Secretary, RMC, Nabarangpur by Registered Post/ Speed Post only. The RMC, Nabarangpur is not responsible for any postal delay. The tender shall be opened on the 31.03.2020 at 11.00 AM in presence of the Tender Committee and also bidders or their authorized representative in the Office of the Regulated Market Co0mmittee, Nabarangpur. Tender without requisite document as mentioned in Annexure-II will not be accepted.



- 12. The Application form of tender containing General Bid Information & Terms and conditions for hiring of Vehicles will be available with RMC, Nabarangpur Office on any working day during office hour on payment of Rs. 500/- (Rupees Five hundred only) up to 5.30 PM of Dt. 24.02.2020 to 23.03.2020 from the District Website www.nabarangpur.nic.in. in case the application form is downloaded from website, the applicant shall furnish a Demand Draft for an amount of Rs. 500/- (Rupees Five Hundred) only towards the cost of application along with the tender in favour RMC, Nabarangpur.
- 13. The bidder is to furnish declaration as stated in Annexure-III along with the Bid.

(B) TERMS & CONDITIONS FOR HIRING OF VEHICLES.

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

- 1. The hired vehicle, during period of contract, shall have all necessary valid MV documents such as :- valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, proof of up to date tax payment etc., and D.L. of the driver available all the times. The Department/Office hiring the vehicle shall not be responsible for any damage/ loss caused to hired vehicles or loss of life/ injury made to any person or damage to any property on account of use of hired vehicle in any manner whatsoever. The travel agency /tour operator/ private individual shall be responsible for all such litigation.
- 2. The hire charges to be paid for monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption. All the expenditure of the vehicle towards repair and maintenance, replacement of spare parts, Lubricating oil of Engine, Gear Box & differential Coolant, Tyres & Tubes, battery etc. will be borne by the bidder.
- 3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
- 4. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.
- 5. In case of the vehicle do not repost regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
- 6. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demand.
- 7. Monthly hire charges will be paid in every succeeding month, as far as possible within 15(fifteen) days of the submission of bills by the service provider and no advance payment will be made.
- 8. The vehicle shall not be more than 3 (three) years old from the initial registration and also in good running condition during the period of contract.
- 9. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant 1(one) month notice before such withdrawal of service and termination of agreement.
- 10. If the bidder violates any of the terms of contract, the R.M.C. shall forfeit the entire amount of E.M.D.
- 11. Any dispute arising in respect of the terms & Conditions of the agreement, the matter will be decided in the court of law, within the jurisdiction of Nabarangpur District.
- 12. The authority reserved the right to cancel /reject the tender without assigning any reason thereof.
