## 5. Evaluation of Quotations

The purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which

- (a) Are properly signed and
- (b) Confirm to the terms and conditions, and specifications.
- (c) Products with ISO certification shall be preferred.

The quotations would be evaluated for all the items taken together.

## 6. Award of Contract

6.1 The purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price. However, products with ISI/ISO certification shall be considered taking into consideration of quality and durability instead of lowest bid.

6.2 The bidder whose bid is accepted will be notified of the award of contract by the purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.

7. Payment shall be made after delivery, testing & complete installation of the goods through A/C payee cheque after submission of the bills and vouchers.
8. Any effort by a bidder to influence the purchaser in its decision on bid evaluation or placement of purchase order may result in rejection of the bidder's offer.
9. Any legal dispute arising out of this is subject to concerned district jurisdiction only.
10. Notwithstanding the above, the Municipal Office, Umerkote reserves the right to accept or reject any quotation and to cancel the bidding process and reject all bids at any time prior to the issue of contract letter. The bidders may be present in person or through one of their representatives during the opening of quotations as per the date and time fixed by the Municipal Office, Umerkote.
11. 1% EMD bidding price of bidder shall be deposited by the intending bidders in shape of Account Payee Bank draft drawn in favour of the Executive Officer, Municipality, Umerkote payable at any nationalize bank, Umerkote and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
