## TERMS & CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

- The hired vehicles, during period of contract, shall have all necessary valid MV documents such as:- valid Registration Certificate, Insurance Certificate, fitness Certificate, valid Contract Carriage Permit, proof of up to date tax-payment etc, and D.L. of the driver available all the times. The Department / Office hiring the vehicle shall not be responsible for any damage / loss caused to hired vehicle or loss of life / injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.
- The hire charges to be paid for monthly basis which does not include cost of diesel/ petrol
  which is to be paid separately basing on actual consumption and lubricants as per existing
  government norms. All the lubricating oil of engine, Gear Box and differential coolant, Tyres and
  Tubes, Battery etc. will be borne by the bidder.
- It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the bidder.
- In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle / bidder.
- In ease of the vehicle do not report regularly, the authority will be at liberty to reject the
  agreement and may engage vehicle and may engage vehicle from other source.
- · The vehicles shall report for duty for minimum of 25 days in month.
- In case of emergency, the driver will have to report for duly as per the requirement of hirer. No
  extra payment shall be demanded.
- Monthly hire charges and reimbursements towards cost of diesel (as per actual) and Lubricants (as per govt. norms) of selected bidder will be paid in every succeeding month, As per as possible within fifteen days (15) of the submission of bills by the service provider and no advance payment will be made.
- The vehicle shall be in good condition and shall not be older than three years. The hired vehicles cannot be used for any private/ commercial purpose beyond office hours or during holidays.
- GST Registration is compulsory for any service provider to provide hired vehicle.
- If the services area found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
- In case the service provider intends to withdraw the services of his vehicle and terminate
  the agreement, it shall be mandatory upon him to grant one month notice before such
  withdrawal of service and termination of agreement,
- If the bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit.
