DETAILS OF TERMS & CONDITIONS FOR APPOINTMENT OF TRANSPORTING AGENT FOR TRANSPORTATION OF RICE/ WHEAT UNDER W.B.N.P (SNP & SAGPROGRAMME) FOR THE YEAR 2020-2021 FOR NABARANGPUR DISTRICT

- 1. The Tenderer shall carefully go through all the terms and conditions of the tender documents and submit the tender papers correctly and in complete from. The tender paper should be filled in properly and legibly without any correction/ overwriting. No opportunity shall be given to the Tenderer to rectify or amend any defect detected at the time of scrutiny. The rate should be final and the Tenderer shall not be allowed to change the same under any circumstances and it should be valid for the year 2020- 2021.
- 2. The approximate quantity of food stuff to be handled in a Month/ Year will be as follows:-

- 3. The successful Tenderer shall be required to lift Rice/ Wheat from F.C.I. Depot and deliver the stock to the ICDS, AWC's and SHG's Point. Stock shall be delivered to ICDS, AWC's and SHG's point on proper weighment as per diversion order issued by the DSWO, Nabarangpur and concerned C.D.P.O's within stipulated period of 10 days.
- 4. The Tenderer should have minimum Ten trucks (HGV-5, MGV & LGV-5) (with all valid document i.e. RC, Tax, Fitness, Permit & Insurance) standing in his own name i.e. Proprietor, Firm, Partners & Directors. It is the responsibility of the transporting agent to lift the Rice/ Wheat from FCI/ RRC Depot and deliver the same to the ICDS, AWCs/ SHG Points on proper weighment in the presence of the members of the Janch Committee and in no case short supply or delivery shall be made by agent to the ICDS, AWC's and SHG's point. The agent will be held responsible for shortage and damage noticed if any during transit. The quality and quantity of the foodstuff being transported can be inspected by the Govt. Officials authorized by Collector during transit and at the delivery point. If any misappropriation is noticed, penalty shall be levied which would be equivalent to 4 times of the cost of misappropriated food grains apart from initiating criminal cases.
- 5. No Individuals, Company, Firm, Corporation shall participate in the tender process unless it possesses valid all Odisha Certificate or Registration [Sec Rule 5(1) of the carriage by Road Act, 2007 & carriage by road rule, 2011].
- 6. Firms having past experience of transporting commodities of different government schemes will be given preference.
- 7. The Tenderers should submit the following documents along with the tender paper. In absence of any document/ paper, the tender paper will be liable for rejection by the component authority. The Tenderer shall have to produce the original documents if necessary before the tender committee for verification.
 - a) Original Tender paper duly signed by the Tenderer as token of acceptance of the terms and conditions of the tender.
 - b) Attested copy of Valid Income Tax, Pan card Voter I.D of the Proprietor/ Partner/ Firm.

- c) Attested copy of the Recent Solvency Certificate (issued for the year 2020-2021) for Rs.1.00 Crore (Rupees One Crore) from the competent authority should be furnished along with the tender paper failing which the tender will be liable for rejection. No Bank solvency should be entertained.
- d) Attested copy of certificate from any Govt. Organization about past experience and performance of the Tenderer in transportation for same work required.
- e) Earnest Money Deposit of Rs. 15,00,000/- (Rupees Fifteen Lakh) only in shape of NSC/Terms Deposit (of a nationalized bank only) duly pledge in favour of the D.S.W.O Nabarangpur shall be furnished along with the tender paper. Without Earnest Money Deposit, the tender paper will be liable for rejection. Cash/ Cheque and Bank Draft shall not be accepted. No request for transfer or any previous deposit or adjustment of earnest money for any claim payable will be entertained. Any deviation to the above to the stipulation will entail complete rejections of the tender paper. No Tenderer shall be allowed to withdraw his Tender/ Earnest Money Deposit until the tender is finalized. In case the successful Tenderer refuses to be the transporting Agent after acceptance of his tender the Earnest Money Deposited by him will be liable for forfeiture.

The E.M.D of the unsuccessful Tenderer shall be refunded after finalization of the tender; whereas the E.M.D of the successful Tenderer will be kept as security deposit and will be released after successful completion of contract period, settlement of payment thereof and audit of such account and after obtaining the audit report. The DSWO, Nabarangpur is not liable for payment of any interest on the Security Deposit or any depreciation thereof. The breach of any terms and conditions as per agreement and failure/ unwillingness to under transportation work by the selected Tenderers within the time limit after acceptance of his tender may lead to forfeiture of E.M.D and black listing of the Firm.

- f) Bank Guarantee of Rs.10,00,000/- (Rupees Ten Lakh Only) will be submitted by the successful Tenderer.
- g) List of trucks Owned/ in the name of the firm or Partner by the Tenderer with up to date valid documents (R.C, fitness, Permit, tax & Insurance) (Xerox copy of duly attested) shall be furnished along with the tender.
- h) The Tenderer should file an affidavit either from the Executive Magistrate or from the Notary that "he has not been convicted in any criminal case, defaulter and being black listed".
- i) Attested copy of the firm must be registered under office of the Inspector General of Registration cum Register of Firms, Cuttack.
- j) Attested copy of Income Tax returns of past three years.
- k) Attested copy of Income Tax Balance sheet of past three years.
- 1) Attested copy of Income Tax clearance Certificate for the year 2018-19.
- m) Attested copy of Deed of partnership, if the Firm is a partnership Firm.
- n) The Tenderer or his relatives (family members) should not be a transporting agent of OSCSC Ltd. (L-I & L-II) in Nabarangpur District.
- o) The Tenderer or his relatives (family members) should not be a Rice miller in Nabarangpur District.

- 8. The successful Tenderer shall deliver the stock through Challans to be maintained in triplicate, first copy to be handed over to the C.D.P.O of the concerned ICDS, 2nd copy to be kept to attach with the bill and 3rd copy for book paste in the Challan book.
- 9. After completion of distribution of rice/ wheat, the successful transporter shall submit AWC/SHG point wise distribution list indicating Challan no., date of supply and quantity supplied. The CDPO of the concerned ICDS shall compile the distribution list with the delivery Challans received on daily basis.
- 10. Payment shall be made within one month from the date of receipt of bills complete in all respect along with a certificate indicating the quality and total quantity of stock disteibuted. The payment will be made subject to availability of funds and no interest will be paid for any delayed payment. No advance payment will be made.
- 11. Good conduct, dealing with officials shall be an implied condition for continuance as Transporting Agent.
- 12. The Collector Nabarangpur may terminate the contract for violation of terms and conditions of agreement as well as any change of policy in the Government or for any reasons to be recorded in writing.
- 13. In case of violation of conditions of tender, the Agent will be booked under IPC, essential Commodities Act, Prevention of Food Adulteration Act and prevention of Black Marketing Act.
- 14. No request for enhancement of approved rate shall be entertained during the terms of Agreement.
- 15. No financial Bid (Annexure-II) will be open after qualifying the technical Bid (Annexure-I)

The right of acceptance of tender rests with the Collector, Nabarangpur also reserves the right to cancel or reject any or all the Tenders without assigning any reason thereof in case of any dispute.
