TENDER CALL NOTICE


Sealed quotations are invited in prescribed format from the intending Travel Agencies/ Tour Operators or private individuals for providing one nos of Bolero/Sumo Gold/TUV 300 Non AC/AC Diesel driven vehicles having seating capacity not more than ten including driver, which shall conform to the Terms and conditions (Annexure-II) for official use in W & CD and Mission Shakti/ICDS, Project, Chandahandi, Department/Office on monthly rent basis, valid Xerox copy of RC Book and insurance should be attached with the quotation.

Intending Vehicle Owners are required to submit the sealed quotations to the undersigned on or before 09.07.2020 during the office hours and the same will be opened on 09.07.2020 at 11.00 A.M. in presence of the Sub-Collector, Nabarangpur in the premises of ICDS Project Office, Chandahandi. The quotationer or their authorized agents are required to attend this office at the time of opening of quotation along with the vehicle and its original documents for verification.

Terms and Conditions:

1. The vehicle shall not be more than 3 years old from the initial Registration; Only POL charges will be borne by the office. All the expenditure of the vehicle for repair, replacement of spare parts, Lubricating oil of engine, Gear Box & coolant will be borne by the owner.
2. Vehicle owner will bear both major and minor and maintenance of the vehicle and salary of Driver.
3. Failure to perform duty due to break down of the vehicle will make liable to owner of the vehicle to provide another vehicle in order to avoid any disruption in the day to day work of the office.
4. The vehicle must have valid Registration Certificate, Insurance Certificate, Fitness Certificate valid contract carriage Permit, Up to date Tax clearance and valid D.L. of the driver.
5. The vehicle shall report for duties for minimum 25 days in a month. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement.
6. If the service of the vehicle found to be unsatisfactory, the undersigned shall give 15 days' notice and terminate the agreement.
7. The successful quotationer will deposit Rs.5,000/- as security deposit and execute required agreement with the CDPO, Chandahandi on the date of selection unfailingly.
8. The period of deployment of vehicle on same rate may be extended from time to time on availability of funds.
9. The Driver should well behaviour, gentle and obedient in nature.
10. The monthly rate of hire charge be quoted separately in the general bid information. (excluding fuel and lubricants)
11. The vehicle must archive a fuel efficiency of 12 KM.s per litre.
