SHORT TENDER CALL NOTICE NO. 02/2020-21

Sealed tenders in plain paper are invited from the Individual/proprietor/authorized dealers /reputed suppliers for supply of the Kusumi Brood Lac for June/July Cycle to the selected farmers of ITDA, Nabarangpur for Lac Cultivation.

The details of specification, terms & conditions are available in the Website http://www.nabarangpur.nic.in from 10.00 AM of 03.06.2020 to 15.07.2020 up to 11.00 AM and can be downloaded from the Website. The bidder should pay the paper cost of Rs. 6,000/- in shape of Bank draft / Bankers Cheque drawn in favour of the Project Administrator, ITDA, Nabarangpur, payable at SBI, Nabarangpur.

The Earnest Money Deposit (EMD) i.e. 1% of the tender value is to be deposited in shape of NSC/ POTD / STDR/ KVP duly pledged in favour of the Project Administrator, ITDA, Nabarangpur along with Tender papers. The sealed tenders should reach the office of the undersigned on or before 15.07.2020 up to 11:00 AM by <u>REGISTERED POST/ SPEED POST ONLY</u>. The tenders will be opened on 15.07.2020 at 03.30 P.M in the office of the Project Administrator, ITDA, Nabarangpur in the presence of the bidder or their authorized agents.

Terms & Conditions for supply of good quality Kusumi Brood Lac:

- I. The rate quoted is inclusive of all the taxes and cost of transportation door delivery at Project Locations of ITDA, Nabarangpur, Dist- Nabarangpur, Odisha.
- II. The Tenderer should submit his tender paper with valid sales tax clearance and TIN No., up to date GST clearance certificate and registration certificate for the year 2019-20.
- III. The successful Tenderer will have to deposit Security Amount of 5% of the total cost of articles in shape of Cash / NSC/ POTD/ STDR duly pledged in favour of Project Administrator, ITDA, Nabarangpur.
- IV. Shortfall of any required documents, Drafts and EMD, the tender is liable for rejection.
- V. The authority reserves the right to reject any or all tender without assigning any reasons thereof.
- VI. Place of supply: All the places of Lac Growing areas selected by ITDA, which includes Chandahandi, Raighar, Umerkote & Jharigam Blocks of Nabarangpur District. (Specific Locations will be mentioned at the time of supply order)
- VII. If the supplier fails to supply the Brood Lac within stipulated period as per the purchase order, the order will stand automatically cancelled and EMD & security money will be forfeited to Govt.
- VIII. The supply of Brood Lac seeds should be as per standard laid down by the IINRG, NAMKUM, RANCHI. Brood Lac not meeting standard will be rejected without any liabilities on the part of the undersigned and a proportionate deduction will be made if found wanting in the length/weight ratio provided other standards are made. Supply of seeds to be completed within the schedule date as shown in the supply order.
 - IX. The Sample brood lac should be submitted on the day of opening of sealed tender along with certificate from IINRG, Ranchi Scientist as regards to the quality standard of brood lac.
 - X. The supply of Kusmi Brood Lac should be made within 48 Hrs. (Forty eight) from the date of emergence of Larvae.
 - XI. Supply of Brood Lac will have to make in packing of new bamboo basket over with gunny bag and each basket must contain 12 Kg of healthy Brood Lac covered with gunny bag lid on the top.
- XII. The undersigned does not guarantee of taking up of any Brood Lac and no compensation will be payable to the supplier in question, if not taken up due to any reason whatsoever.
- XIII. Royalty for any materials if obtained from forest area will have to be paid by the Supplier and as such it should be included in the rates quoted. As the carrying cost is included in the rates, so no any further amount to be paid for supply.
- XIV. The undersigned reserves the right to cancel the contract on ground of unsatisfactory or delayed supply and failure to fulfill terms and conditions of the agreement.
- XV. The bidder should have 3 (three) years prior Experience in supply of Brood Lac to any Govt./Semi-Govt. organization and Public Sector Unit. A Certificate in this

regard from purchasing authorities on supply of Brood Lac by the concerned bidder is required, failing which his/her tender paper is liable for rejection.

XVI. Bidder with IINRG, Ranchi affiliation will be given preference.

XVII. Bidder has to give IINRG, Ranchi trained instructor at the time of incubation for at least three days. The detail of instructor along with IINRG certificate must be inside tender paper.

XVIII. The tenderer should furnish the PAN Card copy; Income Tax return for the

assessment year 2019-20 should be submitted.

XIX. The Notice along with all condition mentioned herein before shall also be a part of agreement to be executed by such bidder for supply of Brood Lac.
