If successful, the bidder who has not registered under State Government, Odisha has to register under the state PWD in appropriate call for eligibility before signing of the agreement.

4. **Abnormal Bids** :- If any of the bidder quotes more than 14.99 % of the tendered amount , then such a bid shall be rejected and the tender shall be finalized basing on merit of the rest bids and the provision laid down in Clause No. 36 of Memorandum No. 12366 dated 08.11.2013 of works departments , Govt, of Odisha will be followed.
5. Tenderers are requested to quote their rate both in words and figures. The Tenderers are required to put their signature on every over writing or any correction made in the tendered rate. The tender filled in figure only but without mentioning in words shall be liable for rejection for which no tender paper cost shall be returned to the tenderers.
6. The Tender schedule along with unit rate of item should dully filled in and all relevant papers in sealed cover will be received through **Registered post / Speed post** only by the undersigned up to 5.30 PM on date. 13/01/2021 and it will be opened in the **Office of the Panchayat Samiti, Dabugam** at **11.00 AM** on dated. 15/01/2021 by the undersigned in presence of the tenderers or their authorized representatives who may be present at the time of opening. The bidder must super scribed the name of the project in the top of the sealed cover.
7. **Telegraphic tender will not be accepted.** The undersigned will not be held responsible for the postal delay if any for the delivery of the documents or non-receipt of the same in time. However no tender will be received by **Fax or by E-mail** .
8. Scheduled Cast and Scheduled Tribe and physically handicapped tenderers will deposit EMD as 50% of the amount put to tender and they will produce Caste Certificate & Physically Handicapped Certificate at the time of purchasing tender papers
9. In case of Engineering contractors seeking exemption of EMD of the work, are instructed to produce an affidavit regarding his / her list of works for which he / she has claimed such exemption and being avoided such works, during current financial year- 2020-21.
10. After opening the tender document the item percentage bid shall be multiplied by estimated quantity of work and the tabulated total abstract value so arrived shall be considered for finalization of tender.
11. Where the tabulated total abstract value offered in a bid works out to an amount, which is **15% less** than the approximate value of work, then the bid document shall be rejected.
12. **Additional performance security Deposit** Where the tabulated total abstract value offered by a bidder works out to **0.01% to 14.99%** less than the approximate value of work, then the bidder has to quote the exact amount of differential cost (i.e. **estimated cost put to tender minus the quoted amount**) as additional performance security in shape **BD / BC / NSC / KVP / STDR / TDR** duly pledged in favour of **Block Development Officer, payable at SBI Dabugam** along with tender document at the time of receipt of tender document.
13. If L1 bidder does not turn up for agreement after finalization of the tender, then he shall be debarred from participation in bidding for three years and action shall be taken to blacklist the contractor. In that case, the L2 bidder, if fulfils, other required criteria would be called for drawing agreement for execution of work subject to the conditions that L2 bidder negotiates at par with the rate quoted by the L1 bidder otherwise the tender will be cancelled. In case a contractor is black listed, it will be widely published and intimated to all departments of Government and also to Govt. of India agencies working in the state.
14. If the tabulated abstract value of two or more bid is equal, then the tender will be finalized on the basis of lottery drawn in presence of such bidders.
15. **Forfeiture:-** The E.M.D amount will be forfeited, if tenderer backs out from the offer of acceptance of tender, by the competent authority.
16. Submission of more than one tender paper by a bidder for a single work will be liable for rejection of all such tender papers.
17. The authority reserves the right to reject any or all the tenderers without assigning any reason thereof.


