1 The Block Development Officer, Raighar invites sealed tenders in Conformity with detailed tender call notice to be drawn up in State P W D-2 Contact from the eligible registered Contractors of State P. W. D/Irrigation/R. W/R. W.S. S & P H E D having valid license from the competent authority for Civil works. The proof of registration from the appropriate authority shall be enclosed along with the Bid, if successful, the bidder who has not registered under State Government, Odisha has to register under the State PWD in appropriate class of eligibility before signing of the agreement.

The cost of tender documents (Non-Refundable) specified in Col-05, shall be deposited at the time of receipt of the tender papers in shape of Banker cheque/Bank Draft only in favour of Block Development Officer, Raigar payable at State Bank of India, Raigar.

Tender must accompany with 1% EMD as mentioned in Col-04, in shape of Bank Draft from any nationalised Bank and duly pledged in favour of Block Dev. officer, Raigar, payable at S B I, Raigar along with attested copies of valid and up to date GSTIN,CC/PAN/TIN certificate, experience certificate from competent authority without which the tender will be liable for rejection.

2. The bidders are required to quote their percentage rate both in words and figure. The bidders are required to put their signature on every over writing or any correction made in the tendered rate. The tender filled in figure only but without mentioning in words shall be liable for rejection for which no tender paper cost shall be returned to the bidders.
3. The tender schedule along with bill of quantities duly filled in and all relevant papers in sealed cover will be received through Registered post/Speed Post only by the undersigned upto 16.1.2021 at 5.30 PM and it will be opened in the office chamber of the Block Dev. Officer, Raigar on 19.01.21 at 11.00 A M by the undersigned in the presence of the bidders or their authorised representative who may be present at the time of opening.
4. Telegraphic tender will not be accepted. The undersigned will not be held responsible for the postal delay if any for the delivery of documents or non-receipt of the same in time. However no tender will be received by Fax or by e-mail.
5. Scheduled caste and Scheduled Tribe & Physically Handicapped Tenders will deposit EMD as 50% of the amount as mentioned in Col-04 and they will produce recent issued of caste certificate, Physically Handicapped certificate at the time of submitting tender paper.
6. In case of Engineering Contractors seeking exemption of EMD of the work, are instructed to produce an affidavit regarding his/her list of work for which he/she has claimed such exemption and has not availed such exemption during current financial year 2020-2021.
7. The conditional tender will not be accepted on any circumstances by the authority, When the bidders will quote the rate less than the estimated cost put to tender shall have to furnish the exact amount of differential cost(i.e., estimated cost put to tender minus the quoted amount) as Additional performance Security in shape of Demand Draft only in favour of Block Dev. Officer, Raigar, Payable at SBI, Raigar at the time of execution of agreement. Deposit in any other shape except Demand Draft will not be entertained. Shortfall of any required documents, drafts on EMD, tender paper is liable for rejection.
8. If the tabulated abstract value of two or more bid is equal, then the tender will be finalised on the basis of lottery drawn in presence of such bidders.




