Financial Bids:-

The Financial bids of the successful Bidders only in Technical Evaluation will be opened. Financial Bid must be submitted as per the format at Annexure-B.

Earnest Money Deposit:-

As part of its Technical Bid submission, the bidder would be required to submit an Earnest Money Deposit (EMD) amounting to Rs. 13,100.00 (Rupees Thirteen Thousand One Hundred) only in form of Demand Draft only. The demand draft should be drawn in favour of Block Development Officer, Jharigam payable at SBI, Jharigam. The EMD of unsuccessful Bidders will be returned after the selection of successful Bidder (without interest). For successful bidder, the EMD will be return only after successful completion of delivery of pictorial tiles. Any bid submitted without EMD will be out rightly rejected. The EMD will be forfeited because of one or more of the following reasons:

- > The Bidder withdraws its bid during the validity period as specified in Bid.
- > The Bidder does not respond to requests for clarification of its Bid.
- > The Bidder fails to provide the required information during the evaluation process or it found to be non-responsive or has submitted false information in support of its qualification.
- > The Bidder materially alters his Bid during the Bid processing period.

Bid Processing Fee:

As part of its Technical Bid submission, the bidder would be required to submit a Bid processing Fee amounting Rs. 6,000.00 (Rupees Six Thousand) only in form of a Demand Draft payable at SBI, Jharigam in favour of Block Development Officer, Jharigam. The processing Fee is **Non-Refundable**.

Terms and Conditions

- > The delivery of the pictorial tiles shall be made by successful Bidder at the Block headquarter, Jharigam. The damage during transit will be borne by the bidder. A random quality and quantity check will be conducted at the time of each delivery. If the quantity and quality is found nonsatisfactory, Bidder will be subjected to a penalty of up to 100% of the order value.
- > The Tenderers are required to quote their rate both in words and figures. The tenderers are required to put their signature on every over writing or any correction made in the tendered rate. The tender filled in figure only but without mentioning in words shall be liable for rejection for which no tender paper cost shall be returned to the tenderers.
- The Tender schedule along with bill of quantities dully filled in and all relevant papers in sealed cover will be received through Registered Post / Speed Post only by the undersigned up to 5.00 PM on 21/01/2021 and it will be opened in the Office of the Panchayat Samiti, Jharigam at 11.00 AM on 22.01.2021 by the undersigned in presence of the tenderers or their authorized representatives. In case of absence of the tenderers or their authorized representatives on the date of tender opening, his/her tender shall be rejected.

- ➤ Scheduled caste and scheduled tribe & Physically Handicapped tenderers will deposit EMD as 50% of the amount EMD amount i.e Rs 6550 (Rupees Six Thousand Five Hundred Fifty only) and they will have to produce Caste Certificate, Physically Handicapped Certificate as the case may be at the time of submitting tender paper.
- In case of Engineering Contractors seeking exemption of EMD of the work, are instructed to produce an affidavit regarding his / her list of works for which he/she has claimed such exemption and has not availed such exemption during current financial year- 2020-21.
- > The conditional tender will not be accepted on any circumstance by the authority.
- ➤ If the office happens to be closed due to subsequent declaration as holidays by Govt. or local authorities on the date of opening as specified above, tenders will be opened on the immediate next working day at the same specified time and venue.
- > If same amount is quoted by more than one tenderer, then the successful tenderer will be decided by lottery system on the same day.


