TERM AND CONDITIONS FOR SUPPLY OF SPORT ITEMS

1. **Place, Date and Time of receiving of tender:** Sealed tenders from registered/authorised firms must reach to the Principal, Odisha Adarsha Vidyalaya, Jharigam, Dist-Nabarangapur through registered or speed post only, not later than 4.00PM of Date: 23/01/2021 and the tender documents will be opened on Date: 24/01/2021 at Principal chamber of Odisha Adarsha Vidyalaya, Jharigam at 11.00 AM in the presence of procurement committee. This School is not responsible for any postal delay. Tender documents received after the stipulated date and time shall not be entertained.
2. The interested and eligible firms are advised to submit the sealed envelope super scripted "**Tender of supply of Sport items**" to Odisha Adarsha Vidyalaya, Jharigam, Nabarangapur District, pin-764076.
3. **EMD and security:**
 - a. EMD: The intending bidders will submit a demand draft of Rs.1600/- (Rupees one thousand six hundred only) favouring "**THE PRINCIPAL, ODISHA ADARSHA VIDYALAYA, JHARIGAM**" and payable at **Jharigam** along with application form towards Earnest Money Deposit (EMD). Tender document without EMD will not be accepted. No exemption certificates in this regard will be accepted.
 - b. The EMD amount of unsuccessful firm will be refunded without interest after finalisation of tender.
 - c. The successful bidder shall deposit the performance security at 5% of the estimated value in shape of demand draft drawn in favour of "**THE PRINCIPAL, ODISHA ADARSHA VIDYALAYA, JHARIGAM**" payable at **JHARIGAM** which will be refunded without interest after the expire of the period of two months. If the successful bidder fails to execute the complete order of supply in the schedule date and time, the EMD and security money will be forfeited.
4. **Eligibility Criteria: The firm**
 - Should be registered company / firm / sole proprietor having valid licence and registration number.
 - The intending firm should submit the GST, PAN card with original bid document.

- Price quoted should include all tax, duties and levies.

5. The selected firm will have to make an agreement with the principal, Odisha Adarsha Vidyalaya Jharigam within 5 days from the date of finalisation of tender in non-judicial stamp paper for supply of Sport items.
6. **Place of Delivery:**
- The successful firms will have to supply the sport items within 10 days from the date of the issue of work order.
 - No transportation cost is allowed.
 - If the successful bidder fails to supply the sports items within ten days, then he will be imposed with a penalty of 0.5% of the order value for each week of delay or part there of subjected to maximum of 10% of value of the order value.
7. **Payment condition:**
- The bidder will be entirely responsible for all applicable present and future duties levies, charges, licences fees, GST etc. In connection with delivery of goods at site including incidental charges.
 - No advance payment will be given to the selected firm
 - TDS will be deducted as per government norms.
 - All payment will be made to the successful bidder in Indian rupees only.
 - All payment mode will be given in cheque mode only.
8. **Legal:**
- The authority has rights to terminate the contract by giving a writing notice to the suppliers if the bidder becomes bankrupts of otherwise insolvent at any time. In this event termination will prejudice or affect any rights of action or remedy which has accrued or will accrue thereafter.
 - Any dispute arising in respect of the bid shall be instituted with the jurisdiction of the Nabarangapur, Odisha only.
 - The chairperson-cum-The principal of the Odisha Adarsha Vidyalaya, Jharigam reserves the right to accept or reject any or all tenders without assigning any reason thereof.
