The interested bidder may submit their sealed documents in the prescribed format mentioning "Procurement of Pictorial marbles Tiles printed with PMAY(G) ,BPGY & NSPGY Logo to be affixed at the entrance of houses under Rural Housing scheme" on the cover of the envelope through speed post/regd.post to the Block Dev .Officer, Chandahandi by 22.01.2021 up to 5.30 P M.

The cost of tender documents (Non-Refundable) shall be deposited at the time of receipt of the tender papers in shape of Banker cheque/Bank Draft only in favour of Block Development Officer, Chandahandi payable at Bank of Baroda, Chandahandi.

1. Tender must accompany with EMD Rs.6000/- (Rupees Six Thousand) only in shape of STDR/TDR from any nationalised Bank and duly pledged in favour of Block Development. officer, Chandahandi ,payable at BOB, Chandahandi along with attested copies of valid and up to date GSTIN,C C /PAN/TIN certificate, experience certificate from competent authority without which the tender will be liable for rejection.

2. The bidders are required to quote their rate both in words and figure. The bidders are required to put their signature on every over writing or any correction made in the tendered rate. The tender filled in figure only but without mentioning in words shall be liable for rejection for which no tender paper cost shall be returned to the bidders.

3. The tender schedule along with bill of quantities duly filled in and all relevant papers in sealed cover will be received through Registered post/Speed Post only by the undersigned up to 22.1.2021 at 5.30 PM and it will be opened in the office chamber of the Block Dev. Officer, Chandahandi on 23.01.21 at 11.00 A M by the undersigned in the presence of the bidders or their **authorised** representative who may be present at the time of opening. The bidders are required to produce the Original documents/certificate at the time of verification of the attested copies submitted by the bidder. At the time of opening the tender, first technical bid will be opened and then only financial bid will be opened.

4. Telegraphic tender will not be accepted. The undersigned will not be held responsible for the postal delay if any for the delivery of documents or non-receipt of the same in time. However no tender will be received by Fax or by e-mail.

5. Scheduled caste and Scheduled Tribe & Physically Handicapped Tenders will deposit EMD as 50% and they will produce recent issued of caste certificate, Physically Handicapped certificate at the time of submitting tender paper.

6. The conditional tender will not be accepted on any circumstances by the authority. If the tabulation abstract value of two or more bid is equal, then the tender will be finalised on the basis of lottery drawn in presence of such bidders. The bidder shall quote his rate including Procurement of Marbles tiles/GST/Transportation for the aforesaid work.

7. The delivery of tiles shall be made at block headquarter. The damage during the transportation will be borne by the bidder. No damage materials/Logo will be accepted. No excess rate will be accepted. The quality and quantity is found to be non-satisfactory, the intend will be immediately cancelled. The Checking of supply logos will be made 100% by the authority at the time of delivery.

8. The authority reserves all the right to reject or cancel all the tenders without assigning any reasons thereof.



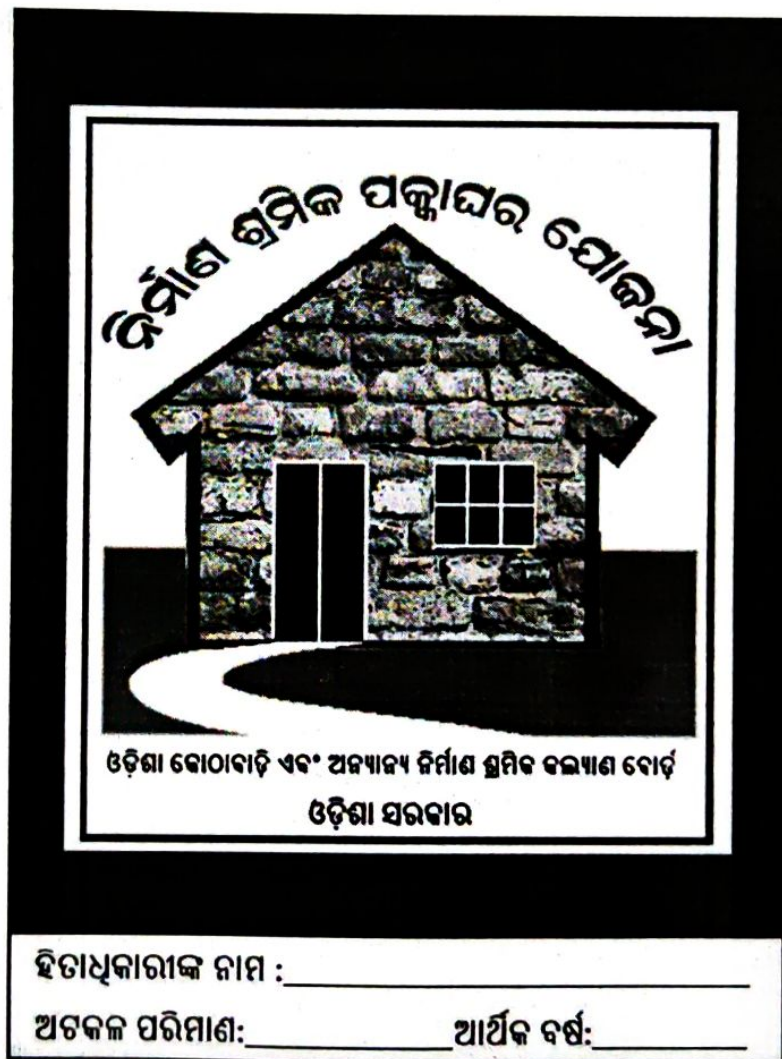
