# garnest Money Deposit:-

As part of its Technical Bid submission, the bidder would be required to submit an Earnest Money Deposit (EMD) amounting to Rs. 10000.00 (Rupees Ten Thousand) only in form of Demand Draft only. The demand draft should be drawn in favour of Block Development Officer, Tentulikhunti payable at State Bank of India, Tentulikhunti, Nabarangpur. The EMD of unsuccessful Bidders will be returned after the selection of successful Bidder (without interest). For successful bidder, the EMD will be returned only after successful completion of delivery of pictorial tiles. Any bid submitted without EMD will be out rightly rejected. 
