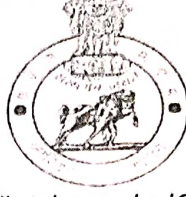




Please find herewith enclosed Corrigendum for web hoisting since some typographical error found in the Tender Call Notice No. 306, dated: 22.02.2021.
