TERMS & CONDITIONS:

- The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid certificate from the Pollution Control Board, valid Contract Carriage Permit, Proof of upto to date tax payment, etc. which are mandatory for applying of vehicle.
- The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle. The Driver should be well behaved, gentle and obedient in nature.
