Sealed Tender is invited from intending Contractors/Firm having valid Contractor Licence of Class-B & C for similar nature of works, GSTIN and PAN for digging of pits of size 30 cm X 30 cm X 30 cm in different plantation sites i.e. Kabkamata under Raighar Range during 2021-22.

The amount of ₹.500/- towards Tender Cost / Participation cost in the process in non-refundable.

The Tender will be received though online in email ID-dfo.ngpur@yahoo.co.in only till 05:00 PM of 25.05.2021 and will be opened online only by the tender committee of the Office of the Divisional Forest Officer, Nabarangpur Forest Division on 26.05.2021. The result of the tender will be published on 26.05.2021 itself. If two or more valid tenderers are in equal quoted rate than transparent lottery will be held on Dtd. 26.05.2021 at 11:00 AM in the office of the Divisional Forest Officer, Nabarangpur Forest Division in presence of the contractor or their authorized agents.

6. Undertaking regarding completion of the works within the stipulated time decided by the Tender Committee.
7. Proof of Experience for carrying out similar works during last years.
8. Proof of Single work order of value not less than 10.0 Lakhs, Two job of similar nature each of value not less than 5.0 Lakhs.

Terms and Conditions: -

1. The Tender documents should be submitted through online/ offline in the Tender Box in the Office in the prescribed format along with all relevant document.
2. The tender documents incomplete in any aspect is liable for rejection.
3. The tenders received after the scheduled date and time is also liable DFO rejection.
4. The price quoted is inclusive of all taxes as mandatory under Government of Odisha like GST, TDS etc.
5. The undersigned reserve the right to reject/cancel any or all the tenders without assigning any reasons thereof and terminate the order in case of changes in the Government procedure of policy of instruction/ direction and exigencies.
6. The payment will be made through FTO in PFMS/IFSM Module or through NEFT/RTGS after receipt of delivery challan and verification physical quantity and quality of the article by the purchase committee.
7. All legal disputes shall be subject to the jurisdiction of the Civil Court, Nabarangpur.
8. The Contractor/ Bidders must submit a willingness certificate for deposit of 1% Bid security of the amount specified to him after finalization of the works duly pledged in favour of Divisional Forest Officer, Nabarangpur Forest Division. Bid security will have to be deposited in A/c No. 31271629868 of State Bank of India, Main Branch, Nabarangpur with IFSC Code SBIN0001320.

Bid must be delivered through online in the E-mail ID specified in tender notice or in Box, in case of any unforeseen technical fault or through Courier/Speed Post etc. The Divisional Forest Officer, Nabarangpur Forest Division will not be held responsible for any postal delay, if any, in the delivery of the documents or non-receipt of the same.
10. Bid documents must be accompanied with a deposit proof of ₹.500.00 towards participation cost.
11. Additional Performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as additional performance security (APS) in shape of deposit in above account number pledged in favour of Divisional Forest Officer within seven days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceedings for black listing shall be initiated against bidder as per the Government of Odisha, Works Department Office memorandum, File No.0124556755555-00000/dated.03.10.2017 of amendment of para 3.5.2 (v) of OPWD Code.
12. 1 % (one percent) of gross bill of the bidder will be deducted towards the labour cess over and above the usual deduction.
13. While making final payment of works 2% towards CGST & SGST and 2% TDS will be deducted from the gross amount to be paid.
14. If the rate quoted by the bidder is less than 15 % of the tendered amount, then such bid shall be rejected as per amendment of Appendix-IX, Clasure-36 of OPWD code vol-II by inclusion.
15. If two or more valid tenderers are in equal quoted rate than transparent lottery will be held on dtd. 26.05.2021 at 11.00 AM in the office of the Divisional Forest Officer, Nabarangpur Forest Division in presence of the contractor or their authorized agents.

16. Bid for the work shall remain open for acceptance for a period of tenderer withdraw his bid/ tender before the said period or make any modifications in the terms and conditions of the Bid, the said earnest money shall be stand forfeited.
