### 1-TERMS AND CONDITIONS

- a- The rate for documentation & videography will be maximum Rs.50,000/(Rupees Fifty thousand) inclusive of all taxes per each school and subject for acceptance of the photos, videos of all the three stages of recording (before, during and after) as per Govt. instructions.
- b- The payment will be made after completion of work in respect of allotted schools on the basis of quality. In case of non acceptance of Photos, videos on the ground of poor quality, you are not entitled for any compensation as the work exercise is a failure.
- c- The duration of the documentation must be minimum 2-3 minutes.
- d- The documentation must be with bytes from different stakeholders including PRIs/ Alumni/ SMC/ Students (Aspirational and Satisfaction levels)
- e- Documentation of each school must be covered with separate school stories.
- f- The agency must capture the videography of school infrastructure (School ambience, smart classroom, playground, e-library, laboratory, sports infrastructure, garden MDM hall, toilets, drinking water facility etc.)
- g- Activities- related photographs include class room teaching & learning, students in playground, prayer class etc should be captured.
- h- Stakeholder meeting like parent-teacher interaction, alumni interaction and SMC meeting should be captured.
- i- Images should be greater than 20 megapixel with a least 72 DPI & shots must be taken from at least three angles (Front, Left, Right) with three different position.
- j- Original and editable photo, video should be sent through mail/Storage device without any editing / compressing.
- k-The check list (enclosed) for documentation & videography should be followed strictly.

- l- The undersigned is not responsible for any loss or damage of the electronic materials/equipments or person of the agency.
- m-Notwithstanding the above, the Collector & DM Nabarangpur, reserves the right to accept or reject any tender and to cancel the bidding process and reject all bids at any time prior to the issue of contract letter. The bidders may be present in person or through one of their representatives(s) during the opening of tender as per the date and time fixed by the project Director, DRDA, Nabarangpur.
- n- Affidavit by the authorized signatory of the bidder that the bidder has not been blacklisted by any Central / State Government (Central/State Government and Public Sector) or under a declaration of ineligibility for corrupt or fraudulent practices as of 31.07.2021 must be submitted on original letter head of the bidder with signature and stamp. (Form-4)
- o- All court cases arising out of this work order is subjected to the jurisdiction of Civil court of Nabarangpur.

#### 2-TECHNICAL BID

- a- Attested copy of PAN Card/GST Registration Certificate.
- b- Attested copy of Bank Account Details.
- c- Bid Letter (Technical Bid & Financial Bid with all documents)(Form-2)
- d- Particulars of the Bidder.(Form-3)
- e- Copy of Power of Attorney in the name of the authorized signatory, if required.
- f- Self Certification (undertaking) own DSLR Camera for still photos & Digital Video Camera for process video.
- g- Minimum 4 years experience and expertise in documentary video and photography in Govt. Sector.
- h- The rate for documentation & videography will be maximum Rs.50,000/- (Rupees Fifty thousand) inclusive of all taxes per each school. The Financial bid of only those bidders shall be opened who will qualify Technical Bid. However, the bidder having lowest Price quoted will be awarded the work order subject to the acceptance of quality of sample Photos, Video (5 minutes of any documentary) to be presented before the tender committee members.
- i- Earnest Money Deposit of amount Rs 12,000/- (Rupees Twelve Thousand) only in shape of Account Payee Demand Draft or Banker's Cheque in favour of the Project Director, DRDA Nabarangpur of the concerned district, payable at the district headquarter from any scheduled commercial bank must accompany with the technical bid. EMD of all unsuccessful bidders would be refunded by the DRDA, Nabarangpur within 180 days of the bidder being notifies as being unsuccessful. The EMD, for the amount mentioned above, of successful bidder would be kept as part of Performance Guarantee till acceptance of final deliverable.

- j- The EMD amount is interest free and will be refundable to the unsuccessful bidders without any accrued interest on it.
- k- The tender paper submitted without EMD, mentioned above, will be summarily rejected.
- l- The bidders shall submit their tender paper as per the following manner
  - a) Technical Bid should remain in the sealed envelope -1 super-scribing "Technical Bid"
  - b) Financial Bid should remain in the sealed envelope-2 super-scribing "Financial Bid"
  - c) The two envelopes containing copies of Technical Bid and Financial Bid shall be put in another single sealed envelope clearly marked "Proposal for Documentation (Video, Audio & Still Photography) of earmarked Schools of Nabarangpur District under 5T High School Transformation Programme"
- m-The outer envelope thus prepared shall also indicate clearly the name, address, telephone number, e-mail ID and fax number of the bidder.
- n- All the pages of the tender paper must be sequentially numbered and must contain the list of contents with page numbers. Any deficiency in the documentation may result in the rejection of bid.
- o- The original bid shall be prepared in indelible ink. It shall contain no interlineations or overwriting, except as necessary to correct errors made by the bidder itself. Any such corrections must be initialed by the person (or persons) who sign(s) the tender paper.
- p- All pages of the bid shall be initialed and stamped by the person or persons who sign the bid.
- q- Tender received late and incomplete will not be considered.
- r- The Tender will be opened on the same day i.e on 19.08.21 at 5.00 PM in the present of the officials/bidder/authorized person.
