SHORT EXPRESSION OF INTEREST FOR DISTRICT OMBUDSPERSON UNDER MGNREGS

Fresh Expression of interest is inviting from persons to be engaged as OMBUDSPERSON in Nabarangpur District for redressal of grievances and disposal of complaints relating to implementations of MGNREGS Act and MGNREGS for tenure of 02 years.

Eligibility Criteria

The person fulfilling the following criteria may apply for selection for district Ombudsperson under MGNREGS.

- 1. Consideration of eminent standing and impeccable integrity with at least Ten years of experience in public administration, law, academics, social work or management as per documents furnished along with the application. Experience in working with people or community organization shall be a mandatory qualification.
- 2. In the selection of Ombudsperson, preference may be given to a person resident of the same or neighboring District so as to take advantage of his/her firsthand knowledge about the District.
- 3. No person who is a member of a recognized political party or a banned organization shall be considered for appointment as Ombudsperson. Each person shall be required to file a declaration to this effect along with the application.
- 4. The applicant must be active person and capable for conducting of field tours, inspection and visits to the remote rural location in the District.
- 5. The applicant should not be more than 65 year of age as on 18.10.2021.

Advertisement

The Ombudsperson in the district will be appointed by the State Government on the recommendation of the Selection Committee.

Remuneration

The Ombudsperson shall be allowed to get compensation of Rs. 1000/- per sitting with maximum upper limit of Rs. 20,000/- per month.

Removal

On unsatisfactory performance, the Ombudsperson may be removed by the State Government on the recommendation of Selection Committee.

Jurisdiction & Location

The State Government shall specify the territorial justification on each Ombudsperson in the term of the District and the office of the MGNREGS Ombudsperson shall be located at District Head Quarters.

The willing person on fulfillment above criteria may submit their written expression of the interest in the prescribed Performa (copy enclosed) along with copy of the required documents to the Collector-cum- DPC, MGNREGA, Nabarangpur on or before 18.10.2021 at 03:00PM through registered post or speed post only in sealed cover superscripting for the post of District OMBUDSPERSON, MGNREGS, Nabarangpur. Application received in any other manner or after the due date will not be considered.

expression of interest without assigning any reason thereof.
