#### Specification of Interventions:

- **Rice Huller-** Single phase electricity required (Capacity-160 kg/hour)
- **Maize Sheller-** Single phase electricity required (Capacity-50 kg/hour)
- **Flour Mill-** Single phase electricity required (Capacity-35 kg/hour)
- **Multipurpose Oil Extraction Unit-** Single phase electricity required (Capacity-15 to 18 kg/hour)
- **Pickles Making Unit-** Equipments, utensils and other tools & machineries etc.
- **Leaf Plate Making Unit-** Leaf plate Press machine, sewing machine etc.
- **Backyard Poultry Unit-** Poultry shed, chicks/birds, poultry feed, feeder & drinker, vaccine etc.
- **Maize Processing Unit-** Poultry feed and corn flour unit along with shed. Only for Producer Groups consisting of minimum 50 members/ Federation consisting of minimum 5 nos. of SHGs.
- SHG must be ready to provide 10 ft x 15 ft room for Rice Huller, Maize Seller, Flour Mill, Multipurpose Oil Extraction Unit, Pickle making unit and Leaf plate making Unit and 15 ft x 20 ft space/ area for Maize processing unit.
- Resolution of the SHG for consent to provide room/ space should be attached along with EOI.

#### Criteria for Identification and selection of SHGs/ SHG Federations:

1. SHG for this purposed intervention includes SHG Federation and PG of SHGs.
2. SHG must have completed one year from date of formation.
3. SHG having more than 60% Scheduled Tribe members. The project provisioning will be restricted to only ST members of the SHGs.
4. SHG should belong to the same block where they proposed to take up the activities.
5. SHG must have an active bank account.
6. SHG must not be a bank loan defaulter.
7. SHG must have undertaken regular and systematic book keeping including maintenance of register, cash book, updated passbook among others.
8. SHGs/ SHGs being part of producer groups undertaking farm and non-farm based activities under Mission Jeevika Programme will be given preference from the applicant SHGs/ federation.
